(For the forest land to be diverted under FCA)


A proposal has been received by the this office from मुख्य प्रबंधक - परियोजना, हिंदुस्तान पेट्रोलियम कारपोरेशन लिमिटेड बरेली NH-30 (चैनेज 294.315 से 325.00 तक दायीं तरफ़), NH-30 (चैनेज 325.00 से 341.00 तक दायीं तरफ़) तथा NH-731 (चैनेज 82.810 कि० मी० से चैनेज 114.265 कि० मी० तक दायीं तरफ़) और अटसलिया रेलवे फाटक से GIC तक के PWD मार्ग पर (कुल 3.8 कि० मी० पर दायीं तरफ़), पर जिला शाहजहाँपुर में गैस पाइप लाइन बिछाई जाने हेतु 4.0945 हे० संरक्षित वन भूमि के गैर वानिकी प्रयोग हेतु diversion (under FCA-1980) of 4.0345 hac. of Protected forest land for non-forestry purpose. The project envisage the use of Protected forest land for laying. The site inspection of the land involved in the proposal has been done by me on dated 25/6/22. On inspection of the site, it is found that the land required buy the user agency is a RF/PF/unclassified/Protect forest measuring PF 4.0945 Hac. The requirement of Protected forest land as proposed by the user agency in col. 2 of part-I is unavoidable and is barest minimum required for the project.
