Sub: Proposal for grant of access permission to a Private Industrial Property of M/s JUGGLER HAWK Industries Pvt. Ltd. at Km. Ch. 209/621 to Km. Ch. 209/671 (RHS) on NH-62 at village-Kenchiya, Tehsil-Pilibanga, Distt. Hnumangarh in the state of Rajasthan.

An Online grant of access permission to the Private Industrial Property of M/s Juggler Hawk Industries Pvt. Ltd at Km. Ch. 209/621 to Km. Ch. 209/671 (RHS) on NH-62 at village-Kenchiya, Tehsil-Pilibanga, Distt. Hnumangarh in the state of Rajasthan. This office vide letter under reference ii) has requested to EE of Office of SE PWD NH Circle, Bikaner to examine the proposal and furnish recommendation in accordance with Ministry's Guidelines issued vide letter No. RW/NH-33023/19/99-DO.III dated 24.07.2013 & 25.08.2014. EE of Office of SE PWD NH Circle, Bikaner has submitted his report vide letter under reference iii). Based on proposal prepared & certification by applicant & recommendation and certification of Check List, Layout Plan, Drainage Plan and Location Plan by EE of Office of SE PWD NH Circle, Bikaner vide above mentioned letter under reference iii), the proposal is examined in this office in accordance with Ministry's Guidelines/ Norms issued vide letter No. RW/NH-33023/19/99-DO.III dated 24th July, 2013 and letter No. RW/NH-33023/19/99-DO.III dated 25.08.2014 and the proposal is granted "in-principle" approval and a provisional NOC subject to following conditions. One set of the original Layout plan duly signed by the Regional Officer (Civil), Jaipur is enclosed. One set of Layout plan has been retained in this office.

- (a) The applicant must execute the access work in close Coordination with the Concessionaire and EE of Office of SE PWD NH Circle, Bikaner.

- (b) The access to Other Property of M/s Juggler Hawk Industries Pvt. Ltd is allowed through service road constructed by applicant as shown in submitted drawing. At the stage of final NOC, service lane as shown in approved proposal on either side must be there at site. License Deed cannot be signed and commencement & construction of Private Industrial property will not be allowed unless the entire length of service lane as per approved drawing is there at site.
- (c) M/s Juggler Hawk Industries Pvt. Ltd shall construct the Private Industrial property along with its access as per approved Layout drawings and provide drainage arrangement as per the approved drainage plan at their own cost within 12 (twelve) months of the issue of this Provisional NOC. After the construction as per approved drawings and to the satisfaction of Highway Administration, the final approval may be given within 30 days of the receipt of the communication from the applicant about the completion of construction work and License Deed may be signed by the Highway Administration. In case, the construction is not done in one year, the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration.
- (d) If, M/s Juggler Hawk Industries Pvt. Ltd. has not construct the Private Industrial property along with its access as per approved Layout drawings and provide drainage arrangement as per the approved drainage plan at their own cost within the extended period the Highway Administration may encash the Bank Guarantee.
- (e) The applicant should adhere to the undertakings given by them in compliance to Ministry's letter No. RW/NH-33023/19/99-DO-III dated 24th July, 2013. It shall be ensured by the concerned Executive Engineer/Project Director, NHAI that the undertakings made by the applicant are complied in all respects. Any discrepancy would lead to violation of the Ministry's guidelines and the approval extended shall stand cancelled.
- (f) Concerned Executive Engineer/Project Director, NHAI shall examine the road safety conditions during/consequent to construction of approaches. In case of any adverse conditions, the matter may be reported to this office. Compliance to the approved drawings and other conditions are to be ensured by them.
- (g) After obtaining "in-principle" approval, the owner shall be responsible for construction and maintenance of acceleration/deceleration lanes, service lanes, channelizers, drainage arrangement, and any additional other undertaking given, drinking water and toilet facilities in accordance with the approved drawing/lay out plan and specification conforming to the norms at his own cost.
- (h) The owner will also ensure that additional undertakings furnished in respect of observations raised by field officer will be complied. In case, the compliance has not been made, the provisional "in-principle" approval is deemed to be cancelled. License Deed cannot be signed and commencement & construction of other property will not be allowed unless the compliances has been made.

- (i) The owner will also ensure Video recordings before and after completion of work and CD of the above recording shall be submitted at the time of signing of License Deed.
- (j) As per Ministry's guidelines, one time License Fee payable to RPAO (NH), MoRTH, Jaipur has not been submitted, same will be submitted before at the time of Final NOC application with 5% increase in license fee for each calendar year.
- (k) The applicant to execute the said access work in close coordination with the Concessionaire .
1. Drain heads to be provided as RCC covered drain.
 2. Pedestrian guard rail (PGR) heads to be provided between main carriageway & proposed access road, for the safety point of view.
4. This issues with the direction & concurrence of Regional Officer (Civil), MoRTH, Jaipur.
