Sub : PR (PIU) Division, Vizianagaram – RCPLWE Programme – Certain Road works required Forest Clearance – Land bank to an extent of 65.53 Acres identified at one location for allotment of CA Land by the Sub-collector, Parvathipuram – Road from Kuntam Road to Tummiguddi via Mettaguddi upto Mandal Boundary in Pachipenta Mandal of Vizianagaram District is to be considered under above land bank – Reg

I invite kind attention to the reference 1<sup>st</sup> cited,

I submit that the Executive Engineer, PR (PIU) Division, Vizianagaram has requested vide reference 2<sup>nd</sup> cited, that the Government have accorded administrative sanction for the 12 road works under RCPLWE Programme and all the works required forest clearance. Further Executive Engineer has requested that the requirement of Land Bank for 12 works as per the authentication of Principal Chief Conservator of Forests, Guntur was submitted as 39.51 Ha. (97.63 Acres). The Sub-collector, Parvathipuram was addressed by the undersigned to indentify Land Bank at one location for allotment of Compensatory afforestation Land for each proposal from time to time for quick process of forest clearance.

Accordingly as identified Land Bank to an extent of 65.53 Acres (26.52 Hects) in Sy.No. 210 of Kotikipent Village, Pachipenta Mandal of Vizianagaram District for allotment of compensatory afforestation for certain works sanctioned under RCPLWE Programme in which the below mentioned work requirement is 2.72 Acres (1.10 Ha) and the details of as mentioned below.

Further, it is submitted that the above land identified in Sy.No. 210 of Kotikipenta village to an extent of 2.72 Acres (1.10 Ha) for the above work for compensatory afforestation (CA) will be transferred and mutated in favour of forest department, Government of Andhra Pradesh for creation of compensatory afforestation. This will be done immediately on receipt of Stage - I approval under FC Act, 1990 for diversion of forest land required for the above work by the Executive Engineer, PR (PIU) Division, Vizianagaram.
