Respected Sir,

National Optical Fiber Network (NOFN) now known as BHARAT NET, a Project of Government of India is launched to empower rural India by democratizing information through broadband. Under this scheme a bandwidth of 100 Mbps will be extended to each Gram Panchayat. It will synergize ongoing and future government programs viz e-GOV, e-Panchayat, AADHAR, etc.

In Gujarat state, RailTel Corporation of India Ltd. (RCIL), on behalf of Bharat Broadband Network Ltd. (BBNL), will establish the network, connecting All 13758 Panchayats of Gujarat by laying appx. 28000 KMS of dedicated OFC, Free of cost ROW has been issued by Government of Gujarat for laying of Optical Fibre Cable.

In this connection an OFC link has been planned in **DHARI Block** for Dhari to Gadhiya T Point. For which Permission from Forest Authorities for **RF routes** has been sought.

There was a query regarding authority letter, FRA, detail in Annex-20, Date, checklist as per the referenced letter. All this queries mentioned above has been solved and the copies of six files have been submitting again. The Commissioning of the Route is very much Important as will Act as to Provide High Speed Broadband Connectivity to Gram Panchayats.

Keeping in view of the Above Emergency, you are kindly requested to go through the re submitted files and process the ROW application further and grant permission for lying of OFC as early as possible.
