DETAIL NOTE ON THE PROJECT

The proposal is hereby submitted for the construction of Link road to Village Gujrehra RD 0/0 to 1/341 Km in Mohal Chakban Rajiana and Mohal Gujrehra, Tehsil Kangra, District Kangra (H.P.). The said road will connect village Gujrehra with road connectivity in Mohal Chakban Rajiana and Mohal Gujrehra, Tehsil & District Kangra (H.P.). The total length of the road is 1.341 km out of which 693 m falls in Forest Land and 648 m falls in Non Forest Land. The road has been constructed by local people around the year 2006. The proposal is hereby being submitted to regularize the violation.

Taking into consideration of urgency of road to provide link to village Gujrehra falling in Mohal Chakban Rajiana and Mohal Gujrehra, which is very important to provide all time weather road. With the construction of this road the people residing in village Gujrehra will be connected with all-time weather road.

The Villages to be connected with road facility are surrounded by forest land so the proposed road has to be necessarily to be passed through forest land. Apart from the Non Forest Land proposed, there is no other suitable non-forest land available in the vicinity. The Project Comprises of the following civil works.

Road Alignment

The adverse impact of the construction on the environment shall be taken care of. The retaining walls shall be constructed along both sides of road and protection works will be carried out. Thus every care shall be taken to minimize the ill effect on the environment.

LOCATION OF THE PROJECT:

The proposed Link road to village Gujrehra RD 0/0 to 1/341 Km will connect Gujrehra village in Mohal Chakban Rajiana and Mohal Gujrehra with road connectivity. The proposed road falls in Mohal Chakban Rajiana and Mohal Gujrehra in Tehsil & District Kangra (H.P.).

JUSTIFICATION FOR LOCATION THE PROJECT IN FOREST AREA:

The proposed link road to village Gujrehra RD 0/0 to 1/341 Km in Tehsil & District Kangra is feasible in the forest land only. Apart from the non forest land proposed there is no other Non Forest land available in the concerned area. The road is already constructed long back in 2006 and the proposal is for regularization of violation. Moreover the village to be connected with road facility are surrounded by forest land so there is no alternate to avoid the forest land. No felling of trees has been done during the construction of road.

Total Population Benefited:

The population of approx. 133 persons (As per Census 2011) living in village Gujrehra falling in Mohal Chakban Rajiana and Mohal Gujrehra will be benefited with the construction of Link Road to Village Gujrehra in Tehsil & District Kangra.

Project objectives:

- Provide all weather road to local people.
- To link the Village Gujrehra with road connectivity.

The project would have lot of long term direct and indirect advantages. Hence the project is requested to be considered.
