## DETAIL NOTE ON THE PROJECT

The proposal is hereby submitted for the construction of Link road from Rah to Sangam via Bhanyankar RD 0/0 to 2/561 Km in Tehsil Kangra, District Kangra (H.P.). The said road will connect village Rah, Bhanyankar and Jatehar Villages with road connectivity in Tehsil & District Kangra (H.P.). The total length of the road is 2561 m out of which 2426 m falls in Forest Land and 135 m falls in Govt. Land. There already exists a path along the alignment of the road which will be followed for entire length.

Taking into consideration of urgency of road to provide link to Rah, Bhanyankar and Jatehar Villages, which is very important to provide them all time weather road. The people of these villages have to travel on foot for livelihood and medical facilities in emergency situations. So the Construction of this road is very important to provide medical and other basic amenities.

The Villages to be connected with road facility are surrounded by forest land so the proposed road has to be necessarily to be passed through forest land. Apart from the Non Forest Land proposed, there is no other suitable non-forest land available in the vicinity. The Project Comprises of the following civil

- Road Alignment
- ➤ Bridge 1 No.
- ➤ Dumping Sites 4 No.

The adverse impact of the construction on the environment shall be taken care of. Cut & fill method shall be used for disposal of muck/debris would be used in filling the embankments of different structures, retaining walls and low lying areas and the balance shall be dumped at the Dumping Site proposed for disposal of muck. Thus every care shall be taken to minimize the ill effect on the environment.

### LOCATION OF THE PROJECT:

The proposed Link road from Rah to Sangam via Bhanyankar will connect Rah, Bhanyankar and Jatehar villages with road connectivity. The proposed road falls in Mohal Rah, Mohal Bhanyankar and Mohal Jatehar in Tehsil Kangra, District Kangra (H.P.).

# JUSTIFICATION FOR LOCATION THE PROJECT IN FOREST AREA:

The proposed link road from Rah to Sangam via Bhanyankar RD 0/0 to 2/561 Km in Tehsil Kangra, District Kangra is feasible in the forest land only. Apart from the non forest land proposed there is no other Non Forest land available in the concerned area. Moreover the village to be connected with road facility are surrounded by forest land so there is no alternate to avoid the forest land. All measures have been taken to avoid / minimize the forest land. Keeping in view the alternate requiring minimum forest land and less felling of trees has been adopted. There already exists a path of about 2 m - 3 m width, which will be followed for the construction of road.

### Total Population Benefited:

The population of approx. 562 persons (As per Census 2011) living in Mohal Rah and Mohal Jatehar will be benefited with the construction of Link Road from Rah to Sangam via Bhanyankar in District Kangra.

### Project objectives:

- Provide all weather road to local people.
- To link the people residing in Rah, Bhanyankar and Jatehar villages with road connectivity.

The project would have lot of long term direct and indirect advantages. Hence the project is requested to be considered.
