JOINT INSPECTION REPORT

A Joint inspection for the proposed site of Baada Deo SHEP (1.5MW) of Geeta Ram S/o Sh. Kali Dass R/O VPO Pressi Teh. Nihri Distt. Mandi (HP) (IPP sole), was conducted by the officers/officials of Govt. Departments dated on 23/02/2018.

Date of inspection: 23-02-2018

Baada Deo SHEP (1.5MW) is Located between Elevation 1210 mtr. to Elevation 1110 mtr. on Kandhi/Jhungi Stream in Distt. Mandi Himachal Pradesh Which is a tributary of Satluj River. The Baada Deo SHEP (1.5MW) project is a run of the river scheme for 1.5 MW power generation. The project site is located on the Left bank of the Kandhi/Jhungi Stream.

During the Joint inspection, forest land **0.9991** hectare in the jurisdiction of forest Division Suket of Distt. Mandi Himachal Pradesh, proposed to be diverted is barest minimum. Detailed inspection components wise, weir site, desilting tank, fore bay, water conductor system, transmission line, power house, switch yard, Dumping site and power house of the proposed project site was inspected and following points were discussed:-

- The proposed alternative was discussed and minimum use of forest land to be used in the project in muhal Katohdhar and Gaali in Tehsil Nihri Distt. Mandi (HP).
- No archaeological monuments or defence establishment are located and involved near the proposed site of the project.
- It was examined that there is no danger to rare and endangered species of flora &fauna involved in the identified forest land area and nearby.
- On the basis of said inspection, it is certified that the **0.9991** hectare Forest land proposed to be diverted is inescapable and other alternative for the proposed SHEP have been explored and the forest land proposed to be diverted is barest minimum. The diversion of proposed forest land will not effect any burial ground, public utility or public water source (spring) etc. Therefore, the above land is recommended for the said purpose.
