Sub: Diversion of 4.035Ha forest land for approach road to ML No. 0016 in Hulikunte Village, Swamymalai Block, Sandur South Range, Sandur Taluk, Ballari District in favor of Kirloskar Ferrous Industries Limited, Bevinahalli. (Proposal No. FP/KA/MIN/143973/2021).

With respect to the above subject, we are hereby submitting our reply to EDS raised by your office vide reference letter dated. 31.05.2024.

1	<p>You have already obtained Stage-I Clearance for Approach Road over an extent of 3.862 ha for this Mining Lease No.0016[Old No. 2245] vide letter No.4- KRC/1483/2024-BAN/564 Dt.03.04.2024 of Government of India. Again, you have submitted this instant proposal for the same Mining Lease No.0016 [Old No. 2245]. In this regard, you are directed to submit proper justification for another road proposal.</p>	<p>Initially, we submitted FDP Proposal No. FP/KA/MIN/44719/2020 online, this road was being utilized by the previous lessee. Due to local issues cropped up recently with this existing road towards Ranajithpura (3.862 Ha), we submitted another application (Proposal No. FP/KA/MIN/143973/2021) for a road towards Nandihalli Village.</p> <p>After the successful completion of the joint survey, it was found that 1.389 Ha of the applied area lies within the FC applied area of M/s. KIOCL, which has now been granted Stage II clearance. Incidentally the same road towards Ranajithpura is proposed for diversion by M/s. KIOCL Ltd also (Proposal No. FP/KA/MIN/QRY/410600/2022) for an extent of 4.864 Ha, for which Stage I Clearance has already been granted in favour of KFIL.</p>



		To avoid local issues, traffic, and road congestion, our primary road has always been towards Nandihalli side (4.035 Ha), and we intend to use this road for the life of the mine. After obtaining Stage II clearance for the said proposal, we will either surrender the 3.862 Ha area to the Forest Department or establish a co-user agreement with KIOCL, depending on the decision of the Forest Department.
2	It is observed in the initially proposal, Segment-3 (0.485 Ha) & Segment-5 (0.904 Ha) that, total extent of 1.389 ha passes through FC obtained area of M/s. KIOCL Limited. Hence, for these segments, you have to submit the proposal for re-diversion under Section-2 of Van (SanrakshanEvamSamvardhan) Adhiniyam, 1980.	<p>We will submit a re-diversion proposal in Form-D through PARIVESH 2.0 and seek prior approval under the Van (SanrakshanEvamSamvardhan) Adhiniyam, 1980.</p> <p>Furthermore, we have obtained an NOC from M/s. KIOCL Ltd, which was submitted to the office via a letter dated 27.02.2024 (attached as Annexure-1).</p>

Kindly consider the above stated justification and recommend our proposal for further grant of Stage-2 Forest Clearance.

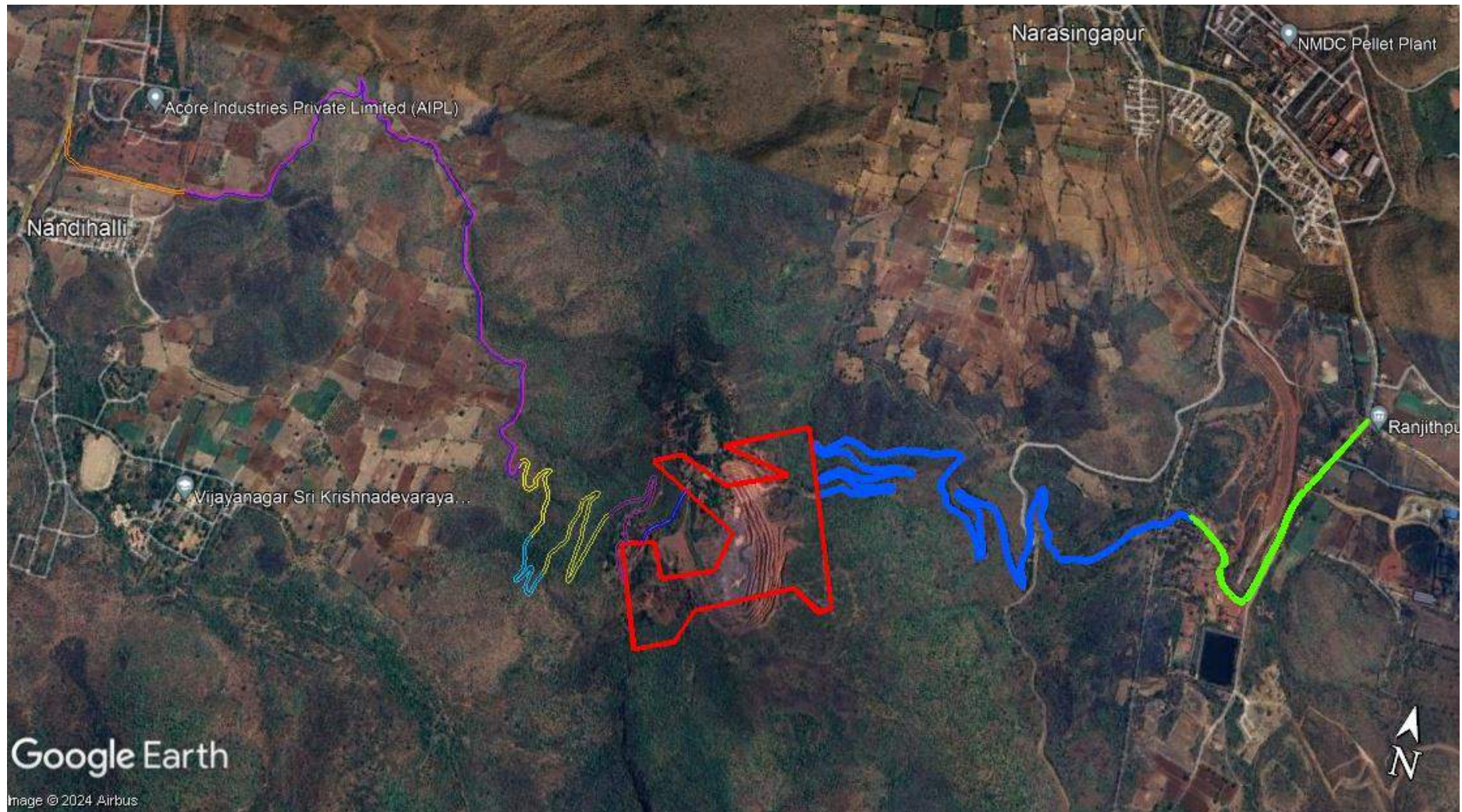
