It is not understood why the additional KML (without name) for 6.82 ha has been sent alongwith other area details? Revised KML with precise area to be sent.	The area to be diverted is 30.25 hectares. The KML file with no name is the forest land of 6.82 hectares adjoining to the proposed area of 30.25 hectares. This land (6.82 ha) is not be diverted. It has now been deleted and the PDF of KML of this adjoining forest land (6.82 ha.) has been attached in the additional documents.
2.	DEM PDF file attached in additional information point no. 14 and 24 in part-1online are not update/according to revised KML shape.	Only the final DEM file with revised KML has been uploaded now. The old one has been deleted from the portal.
