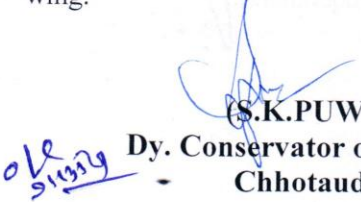

Technical details of Compensatory Afforestation are as follows:

- (G) SMC works Contour trench, Gully plugging, small check dams, construction of van talavadi.
- (H) Protection Trench fencing & Live hedge fencing, Barbed wire fencing
- (I) Silvicultural Operations Cleaning, thinning
- (J) Maintenance Fence repair, cleaning, pruning etc.
- (K) Subsequent silvicultural Operation proposed such as cleaning, cutbacks, thinning etc. (as per species specific requirement) As per working plan scheduled nd thinning will be done at required age in necessary areas.
- (L) Arrangement for peoples participation (if any) for long term sustenance of the plantations. Bhekhadiya Village is already J.F.M. Village and actively involved in forest protection on sustainable base.
- (M) Proposed monitoring mechanism. Monitoring will be done by As per CAMPA guidelines as also indicated by monitoring wing.

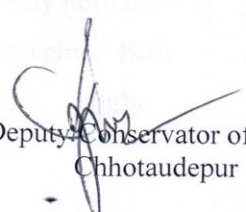

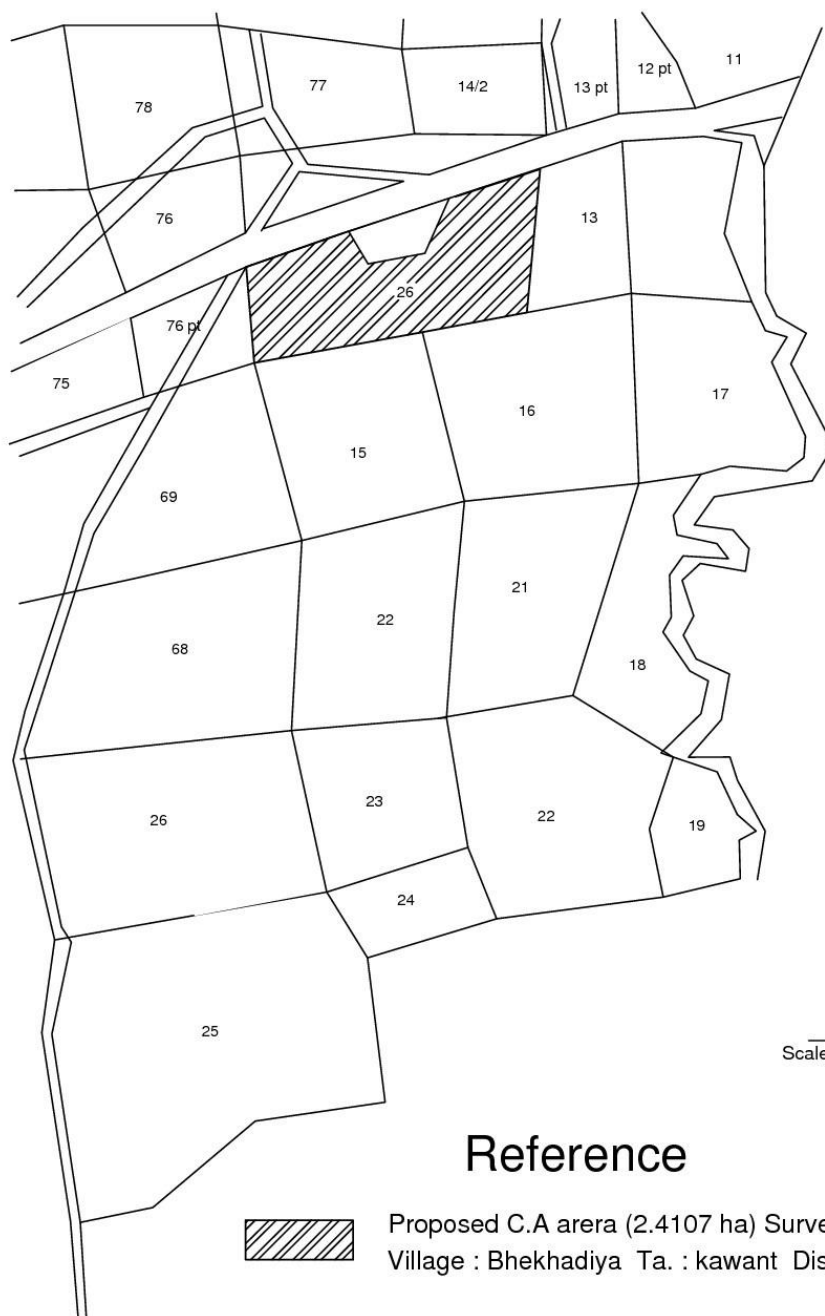
