

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 0.3 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:

- (i) Perusal of KML reveals that the starting point and end point of the proposal appear like forest area rather than non-forest. DFO to carry out inspection and submit a comprehensive report to rule out any such possibility.
- (ii) CF's proposal is incomplete and needs revision. There is no area/proposal number in the recommendation.
- (iii) If the muck is to be dumped in NFL area, UA will be required to furnish a certificate that no muck will be dumped in forest area.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.


