Reply of Queries Regarding Alternate Routes

Before finalization of proposed route of laying OFC over RoW along Existing NH-31 and Village Road passing through Kharabandar Compartment under Jalpaiguri Forest Division Vide Proposal no FP/WB/OFC/146241/2021. 3 more alignments were receed as mentioned below. But all alignments of the routes not found to be suitable due to total lengths of the routes are much higher than the selected proposed route and laying of OFC may not be possible due to Bolder deposition within a depth of 1.5- 3 Mtr and which may cause less disturbance to the Existing Forest & Environment.

Route 1:

Starting Point: 26.86353/88.80303 along NH-31 towards Green Vista Resort (600M) 26.85810/88.80317 To St. Conleth English School (400Mtr) 26.85793/88.80719 to End Point (1100 Mtr) 26.86683/88.80839 totaling 2.1 Km. Map of the alternate Route no 1 is attached.

Route 2:

Starting Point: 26.86353/88.80303 along NH-31 towards Green Vista Resort (600M) 26.85810/88.80317 To Jyoti Ahram (750Mtr) 26.85696/88.81038 to Tea garden (1100 Mtr) 26.86602/88.81255 to End Point (400 Mtr) 26.86683/88.80839 totaling 2.9 Km. Map of the alternate Route no 2 is attached.

Route 3:

Starting Point: 26.86353/88.80303 along NH-31 towards Mangalbari Hat (900M) 26.87177/88.80300 To Sarpoti bagan (1000 Mtr) 26.8691/88.81187 to End Point (450 Mtr) 26.86683/88.80839 totaling 2.3 Km. Map of the alternate Route no 3 is attached.

If the RoW of the road NH-31 (From Chalsa to lataguri) if falls in the Forest areas, our proposal for 370 Mtr out of 870 Mtrs may be considered as per the procedure of diversion of Forest land. Necessary payments for Glawill be paid from Our End on receipt of DN for 0.0348 Ha.




