The Regional Chief Conservator of Forests, Rourkela Circle has forwarded the Site-Specific Wildlife Conservation Plan pertaining to Raikela, Bahamba & Tensa Iron & Manganese ore Mines of Sri Chandi Prasad Sharma with a total financial out lay of Rs.701.6556 lakh (Bonai Division - Rs.634.08 lakh + Keonjhar Division Rs.67.5756 lakh) to the Principal chief conservator of Forests (wildlife) & Chief Wildlife Warden, Odisha, Bhubaneswar vide memo no. 7193/3F(Misc) -31/2023 dated 12.07.2023 and also endorsed a copy to your good office for kind information and necessary action.
