This is the road of a length 20.00 Km of Single lane earthen surface connecting to the State High Road , where the people are suffering a lot for</p>

travelling to the Mandal head quarters and there on to district head quarters for their medical aid, education, transportation of agricultural produce etc.,

By Improving this road to (R&B) Standards, the people will be facilitated to reach the Mandal & district head quarters, for all their needs on time.



Road is sanctioned under RDF Scheme, the government have sanctioned an amount of Rs.3500.00 Lakhs vide GO.Ms.No.1 TR&B(R-II)Dept.dated.02-01-2016.



The same are overlaid on 1:50000 topo maps and enclosed</p>

iv) Justification for location the project in forest area	<p>This road is connecting to the Mandal head quarters and there onto district head quarters for their medical aid, education, transportation of Agricultural produces etc. By improving this road to (R&B) Standards, the people of nearby this road will be facilitated to reach the Mandal & district head quarters, for all their needs on time. The road is passing through forest area and the reach is under the forest jurisdiction of Bhadrachalam North Division.</p> <p>The road is trespassing forest and non-forest areas , if alternate is chosen also still passes through notified forest and leads further defragmentation. Therefore it is proposed for New Formation and Upgradation of Katcha road to Pucca Road.Further,it requires diversion of Forest Land for full width .</p>
