DETAILED NOTE ON THE PROJECT

This is the road of a length 26.00Km of bituminous surfafe connecting to the Major Distict Road , where the people are suffering a lot for travelling to the mandal head quarters and there on to district head quarters for their medical aid, education, transportation of agricultural produce etc.,By Improving this road to (R&B) Standards, the people will be facilitated to reach the mandal & district head quarters, for all their needs on time.

The road is passing through Reserved forest area 12.36816 Km's (in the reach from Km.0/0-26/0). The reach is under the forest jurisdiction of Yellandu Division.

It is proposed to improve. The Telangana State Government have taken a policy decision to improve the interior roads to R&B standards vide GO Rt No.178 T, R&B/ R-I. Dt .02.04.2018. There is no other alternative except proposing upgradation in forest area of Yellandu Division. By improvement the above road, it would improve further connectivity in terms of achieving smooth and safe traffic flow and improve level of service. In addition to above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be acheived.

It is proposed to take up road work along the existing Single lane Earthen road. As such the permission of the forest authorities is required. Hence, proposal is submitted for diversion of forest land worked out to an extent of 24.74 Hectares in management of Yellandu Division.
