No. RVPN/CE/T&C/Sec.5/F.180 (TL)/D. 172 :- In pursuance to the notification Dt. 28-02-2004 issued by the Energy Department Govt. of Rajasthan, Jaipur which was published in the Rajasthan Gazette dated 8-03-2004 at S.O. 408 page 393 (13) Part-4(GA) under Sec. 164 of the Electricity Act, 2003 as well as the powers of the Telegraph Authority under the provisions of the Indian Telegraph Act, 1885 to the Chief Engineer, RVPNL, to erect electric lines/electric plants for the transmission of electricity or for the purpose of telephonic or telegraphic communications necessary for the proper coordination of works. Hence the undersigned to exercise of the above powers, hereby accord the sanction of right of way for erection/construction of **400 KV S/C LINE EXTENDING FROM 765/400KV ANTA GSS TO PGCIL'S 400/220KV KOTA GSS(TWIN MOOSE) TRANSMISSION LINE** for supply of electricity. The said line will pass within the boundary of the following villages :-

Sub: Proposal to inter- connect RVPN's 765/400 kV Anta GSS to PGCIL's 400/220 kV Kota GSS.

The Board of Directors of RVPN in its 193rd meeting held on 22nd March, 11 have accorded its administrative and financial approval for transmission system associated with inter-connection work of RVPN's 765/400 kV Anta GSS with PGCIL's 400/220 kV Kota GSS as per details given below at an estimated cost of ₹ 45.91 Crores (with IDC):

1. LILO of 2nd circuit of 400 kV D/C Chhabra TPS-Dahra section at 765/400 kV Anta GSS (1km, D/C).
2. 400kV bay equipments work at 765/400kV Anta GSS.
3. 400 kV S/C line extension from 765/400 kV Anta GSS to PGCIL's 400/220 kV Kota GSS (45km S/C).

A copy of the Project Estimate Report of the above Scheme, is enclosed herewith for your kind information and needful. The execution of the above scheme is to be done as per individual plan provisions made for each of the scheme in Annual Plan(s) sent to you from time to time.
