

DETAILED NOTE ON THE PROJECT

Back ground and need of the Project:

Roads are the life-line of nation providing transportation facility over the length and breadth of country. Systematic development of road is one of the important prerequisites for development and acceleration of Socio-economic growth of the Country. Among the different modes of transportation systems, road transport carries more than 80 percent of the Goods and Passenger traffic.

The Operations of the (R&B) Department are conducted, in the name and authority of the Governor of Telangana. The Minister for Roads & Buildings in the State Cabinet is responsible to the State Legislature relating to the works of the Department.

The (R&B) Department strives to provide efficient, affordable, customer-focused, environmentally sustainable integrated transportation solutions, connecting villages, towns, cities and centers of industry, commerce, tourism and pilgrimage across the State. The Department constructs and maintains roads and bridges on all roads under its control.

In Telangana State, the road assets of R&B Dept. comprises of 24,245 kms of road length with 3,152 kms of State Highways, 12,079 kms of Major District Roads, and 9,014 kms of Other District Roads.

Details of the Project:

The (R&B) road to R.Kothagudem to Kurnapally road from km 0/0 to 11/6 (via; Danavaipeta , Chinthaguppa ,Bodanalli, Erraboru) road is an Village road in Khammam District road which connects Bhadrachalam .The road passes through several Villages of Agency areas like ; danavaipeta , Chinthaguppa ,Bodanalli, Erraboru Village(s) and also it passes through the Left Extremists Area. In order to bring their medical aid, education, transportation of agricultural produces etc and for the socio economic development in the Agency areas by improving this road to (R&B) Standards, the people of Charla and Dummugudem Mandals will be facilitated to reach the Mandal & District Head Quarters, for all their needs on time.

The R.Kothagudem -Kurnapally road is sanctioned under RDF Scheme, the Government have Administrative and financial sanction for an amount of Rs.1800.00 Lakhs vide GOMs.No 1 TR&B (R-II) Dept, dt:02.01.2016






