No. 115/XIV-331-50- Whereas the Government, Uttar Pradesh is of the opinion that the making of enquiry and record contrary to sub-section (1) of section 25 of the Indian Forest Act, 1927 (Act No. XVI of 1927), will occupy such length of time as to be liable to enlarge the rights of the State Government; now, in exercise of the powers conferred by the provisions of the said sub-section and by sub-section (1) of the said Act, the Government is pleased to declare that ending such enquiry and the provisions of Chapter IV of the said Act to be applicable to the land specified in the Schedule hereto.
