Sub: - Proposal for grant of permission for construction of access to the property of Smt. Santosh yadav W/o Sh. Harindar Singh on NH-24 (New NH-09) in Km. 89 (Ch. 88.690, RHS) at village Garh Banger (Garhmukteshwar), Tehsil Garhmukteshwar & District Hapur in the state of Uttar Pradesh-reg.

Please refer to your letter no. NHAI PERMISSION/2021-22 dated 25.10.2021 vide which Sir. proposal for access permission to the subject proposed private property was submitted and further compliance submitted vide letter dated 29.04.2022.

- In this regard, The Competent Authority i.e., RO-West UP, NHAI, Lucknow has granted 'In Principle approval' vide letter no. 19001/1/RO-W-UP/NH-09/Ch. 88.690/NOC/1305 dated 19.04.2022 in light of Ministry's guidelines issued vide letter No. RW-NH-33032/01/2017-S&R (R) dated 26.06.2020. The "Provisional NOC" granted by the Competent Authority is subject to the following conditions:
- The Provisional NOC is being issued on the basis of submission of Bank Guarantee bearing no. 088GT02221170001 dt. 27.04.2022 issued by HDFC for Rs. 2,50,000/- with the validity (i) of three-year w.e.f. 26.04.2022.
- The Applicant shall be responsible for construction and maintenance of drainage and traffic (ii) control devices.
- The slab culvert shall be constructed with iron granting of adequate strength in the approaches for drainage of surface water. As per clause no. 1.3.3 minimum size of slab (iii) culvert mentioned as 2mX2m.
- The applicant shall ensure the video recordings (before and after completion of construction work) of the site and that the work is done as per approved drawings. (iv)
- Road sign and marking shall be provided as per the relevant codes and guidelines of (iv)
- The approval is based on the submissions made by the applicant. The applicant is responsible for the details provided in the application. The NHAI is at liberty to verify the (v) authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall be led to withdrawal of this approval with costs to the applicant.
- Any unauthorized access from the National Highway shall be cut off and necessary action (vi) be taken as per Ministry's NHAI'S guidelines.
- The Provisional NOC, however, shall be subject to the stipulations of the Ministry's Circular issued vide letter no. RW-NH-33032/01/2017-S&R (R) dated 26.06.2020.
- The applicant may construct the access to the property, as per approved drawings at their own cost within one (01) year of the issue of this Provisional NOC. After the construction as per approved drawings and the certification from this office that the construction work has been carried

out in compliance with the provisions approved, the issue of final formal permission including issuance of signed license deed may be considered. In case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to cancelled, unless revived by the Competent Authority.

- The fresh License deed (duly indicating new NH no. along with Chainage), in two originals, as per the standard format given in Ministry's Circular dated 26.06.2020, drawn on new stamp 5. paper and duly signed by Authorized Signatory may be furnished at the time of issuance of final permission alongwith additional/different License Fee, if any in "Bharat Kosh".
- In view of above, a copy of drawing (layout and drainage plan) as approved by the Competent Authority is being enclosed herewith for taking necessary action towards construction of access to subject private property.




