With Refrence to above cited subject you have applied for permission of laying of 8"/6" mm dia steel and 125mm dia PE gas Pipe Line to cross 1-R distributary at RD \pm 5450, \pm 7850 \pm 17366 and Amloh Minor at RD \pm 60 and along the 1-R distributary from RD \pm 5450 to \pm 17366.

Permission is granted to cross the gas Pipe Line across the 1-R distributary below 4.0m from bed level at RD ± 5450 , ± 7850 , ± 17366 and Amloh Minor at RD ± 60 and 1.50m below N.S.L. near extreme end (left side) of canal boundary along the 1-R distributary from RD ± 5450 to ± 17366 with the following terms & conditions:-

- a. The laying of Pipes will be done strictly as per General Drawings approved by Irrigation Deptt (copy attached).
- b. The levels of Gas Pipes will be in accordance with the Bench Mark of the Canals.
- c. By laying the pipe line below the canal bed, it will be ensured that normal functioning of canal is not affected and irrigation supply not interrupted.

- d. The work will be carried out as per instruction issued at site under the supervision of concerned Executive Engineer (or his representative) of Punjab Irrigation Department.
- e. In case the pipe lines are affected due to future development and improvement of canal system by Punjab Irrigation Department, the cost of laying pipe lines for relaying rerouting/dismantling of pipe line will be borne by the concerned Entity.
