COST BENEFIT ANALYSIS FOR FOREST LAND DIVERSION

(Ref: MoEF guideline No. 7-69/2011-FC(Pt.) dtd. 01st Aug, 2017)

Project:- Diversion of 17.04 Ha of forest land for construction of 33kV S/C Distribution line from Tawang to Y- Junction under Comprehensive Scheme project of Arunachal Pradesh.


