

The specific recommendation for acceptance or otherwise of the proposal is: The 11 KV line to be shifted feeds electricity to the whole Tehsil of Dachhan. It has come under the Pakal Dal Hydroelectric Project and there is no route other than the proposed one. Due to this reason the laying/ shifting of new 11 KV from Dungdoro to Sewarbhati needs to be shifted.
