In compliance to Ministry of Environment and Forest (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF has issued guidelines on submission of evidences for initiating and completing the process of settlement of the rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 05th February, 2013 wherein MoEF has issued certain relaxation in respect of linear projects. Land, area measuring 1.1026 hectares was vide D.L.C.C. meeting held on 04-05-2016 issued F.R.A. certificate on 10-05-2016 which was not on the prescribed proforma, for **link road Village Muhain in km. 0/0 to 1/00**, hence the same on request of H.P.P.W.D. is reissued on the prescribed proforma. It is therefore certified that **1.1026 hectares** of forest land proposed to be diverted in favour of **H.P.P.W.D. for the construction of link road Village Muhain in km. 0/0 to 1/00** in Bilaspur district falls within the jurisdiction of **Kallar village in Sadar Bilaspur Tehsil**.

It is further certified that:

- (a) The complete process for indentification and settlement of rights under the FRA has been carried out for the entire **1.1026** hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the forest rights Committee (s), Gram Sabha (s), Sub-Division level committee (s) and the District Level Committee are enclosed as Annexure 1 to Annexure V;
- (b) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
- (e) The proposal does not involve recognized rights of Primitive Tribal Groups and preagricultural communities.


