#### 1. Project details:

- (i) **Short narrative of the proposal and project/scheme for which the forest land is required:** The scheme is for construction of 400 KV D/C ( Triple Snowbird) Sitamarhi-Motihari Transmission Line. The proposed Transmission Line will connect 400/220 KV Sitamarhi Substation to 400/220/132 KV Sitamarhi Substation (Under Construction) of POWERGRID, Bihar. The line traverses though Sitamarhi & Motihari districts of Bihar. The line will also be an important link of National grid. The line enroute will cross some National/StateHighways & Canals which are protected forest falling in **Sitamarhi** Forest Division where a corridor of 46.0 mtr. will be utilized for construction of the line as well as maintaining electrical clearances during operation.
- (ii) Map showing the required forest land, boundary of adjoin forest on a 1:50,000 Scale map: Enclosed as Annexure-1.
- (iii) Cost of the project: Rs. 80 crore (approx.)
- (iv) **Justification for locating the project in forest area:** Only social forest across. The Gram Panchayat Road, State/National Highways & Canals is being crossed by the said Transmission Line.

- (vi) **Employment likely to be generated:** There will be industrial Development in the country especially in the state of Bihar on implementation of this project. This will create large opportunity of jobs and employment.


