UNDERTAKING

I Sahadat Mandal, being the Mines Manager and authorised Signatory of Nuagaon Iron Mines of Sri Kamaljeet Singh Ahluwalia, hereby undertake to bear the following cost if any on demand and also do hereby undertake to do the following works as per conditions stipulated in Stage II order by MoEF, Govt. of India vide order dated 22.04.2004 and additional condition by Govt. of Odisha, F & E Department.

- i) The Legal status of the forest land will be remained same as earlier to obey the **condition No. 1.**
- ii) We will concurrent reclamation of Mined out pits through back filling followed by afforestation as per the approved Concurrent Reclamation Plan to obey the **condition No.7.**
- iii) We will provide firewood to the labourers and the staff working at the site to obey the **condition No. 10.**
- iv) There will be no any construction in the forest land to obey the **condition No. 8.**
- v) We will take up the tree feeling phase wise as per requirement with obtaining permission from the DFO, Keonjhar to obey the **condition No.6.**
- vi) We will no establish any labour camp in the forest land to obey the **condition No.9.**
- vii) We ensure that there will be no damage to the available wild life to obey the **condition No. 11.**
- viii) We shall not use the forest land for any purpose other than that specified in the proposal to obey the **condition No. 14.**

- x) We will pay the additional amount of NPV, if so determined in later.
- xi) There is no court matter in respect of Nuagaon Iron ore Mines over 767.284 ha of Sri Kamaljeet Singh Ahluwalia except forest cases vide OR No.172BL of 2011-12, 67BL & 68BL of 2011-12. Prosecution has been sanctioned and submitted in the Court of JMFC, Barbil vide PR. No. 2 of 2012-13 and 15 &16 of 2012-13 respectively.
- xii) We will provide the vehicles to the Forest Department for a cost of Rs.20,00,000/- (Twenty lakhs) only, in compliance to the condition of Specific Wild Life Conservation Plan,
