Justification of the Proposal to ascertain the Legitimacy of the Project as Site Specific

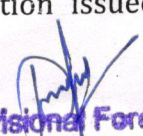

Also, to provide a better and advance learning platform to the Engineering Students undergoing education in the college, hence, the said land is essentially required for the C/o Govt. Polytechnic Jandaur in Tehsil Jaswan Distt. Kangra H.P.

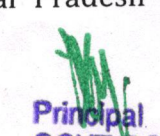
It is submitted that alternative site were explored, but due to involvement of more forest area, near the habitation and involvement of more number of tree in these alternative sites, these alternatives sites were rejected. It is further submitted that the Land holding of the people in Himachal Pradesh is very less and people/local communities are dependent for their livelihood on these small private land holdings and people are not willing to provide their private land for this project. Moreover, in Kangra District most of the land available in and around the periphery is forest land. So accordingly the forest land has been identified for the proposed project as it is found most suitable/feasible because it involve less forest area & less number of trees coming in the alignment, hence cannot be escaped.

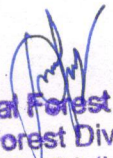
