

ORDER

- 3) That DFO Ramnagar Forest Division shall be the implementing agency for executing the CA Plan.






Technical Details: Technical details of compensatory Afforestation Scheme are as follows:

| i. | General details | An area of 16.4662 ha will be taken up for planting under Compensatory Afforestation scheme in forest compartment No. 5a/N & 03b/N in two blocks. The area will be protected by using square PCC fence posts with Barbed wire fencing and by planting Chir (Pinus roxburghii), and Broad Leaved species) @ 1000 plants per hectare. |
| ii | Plantation Method | Nursery grown two to three years old plants of Chir (Pinus roxburghii), and Broad Leaved Species will be planted in the pits of size 45 x 45 x 45 cm in the selected area. The plantation will be maintained for subsequent 09 years in which beating up failures will be done. The plantation will be rainfed. |
| iii | Spacing | 2.50 mts x 2.50 mts. |
| iv | Species proposed to be planted: | Chir (Pinus roxburghii), and Broad Leaves Species |
| v | Silvicultural Operations: | Existing vegetation is in scattered form and no silvicultural operation required. |
| vi | Soil & Moisture Conservation Works: | Minor Soil Conservation Works like gully plugging, check walls will be done where ever required. |
| vii | Protection (Fencing, Watch & Ward, People Participation etc) | Area will be protected from grazing by erecting barbed wire fencing around the plantation site. Watch & Ward shall be provided with the existing staff including daily rated works. |
| viii | Proposed Monitoring Mechanism | The plantation will be monitored as per existing monitoring mechanism in the forest department. The plantation will also be monitored by GOI representatives as per instructions. |
