

2	There is difference in employment likely to be generated, mentioned Against column No. E in online Part-I and given in hard copy of the proposal. Against column No. E(ii), '0' and against E (iii), '1500' has been mentioned whereas in hard copy of Part-I against column No. I (vi) only '200' man days has been mentioned. The employment details given in online Part-I and placed in hard copy should match.	Needful has been done

4	Although FRA certificate has been uploaded against column No K(i) but VLC level proceedings are photocopies. Further, the SDM level proceedings have not been found uploaded with FRA certificate and also not been placed in the hard copy of the folder. As per GoI instruction against this column FRA certificate in original and attested copies of all the proceedings, Distt. Level, SDM Level and village level duly attested by the issuing department is required to be uploaded against this column and hard copy folder.	Revised FRA Certificate has been attached
5	For muck management still an undertaking has been uploaded. Detailed muck management plan is required to be uploaded in online Part-I and also required to be placed in the proposal folder.	Muck Management Plan has been attached
6	Layout Plan of the proposed college is also required to be uploaded in online Part-I.	Layout Plan uploaded online
7	CA has been proposed in terms of number of plans hence the details of CA patch are not required to be mentioned against column No. 13(i) to (iv). These details are required to be deleted and CA scheme and MAPs are to be uploaded against additional information detail.
