I, Deputy Conservator of Forests, Ghataprabha Division, Gokak inspected the proposed site in Midakanatti area of Khanagaon village in F.S. No.580,711 and 717 on 19-11-2018. The total area proposed is 6.75Ha, and the same was marked on the ground and shown to me. The area is having open secrub/thom forest, with no tree cover. There are vegetation (shrubs) of species like wrightia tinctorial choloroxylon swietenia, etc. The area does not support any prominent and endangered wildlife population and is also not prone to soil erosion.

The Forest land proposed for dirversion is unavoidable as in this lift. Irrigation Project, the water is to be pumped to minimum height, so as to create gravity flow over almost 39.00Kms. and to Irrigate 2710 Ha. of dry land. Except for this proposed site, there is no other land available at height and hence, diversion of Forest land is unavoidable for this project. The Executive Engineer, KNNL, GRBCC Division No. 3, Gokak vide reference (1) has submitted a proposal through web portal mode for diversion of

6.75 ha. of forest land in Sy. Nos. 580, 711, 717 & 718/A of Khanagaon Village, Gokak Taluk, Belgaum District for construction of Chachadi Lift Irrigation Scheme on Markandeya Right Bank Canal for obtaining approval under Forest (Conservation) Act, 1980. Accordingly, a communication through online was made by Nodal Officer vide reference (2) to the Deputy Conservator of Forests, Ghataprabha Division, Gokak and Deputy Commissioner, Belagavi District to process the said proposal and to submit their specific opinion / recommendations.

The Deputy Conservator of Forests, Ghataprabha Division, Gokak, vide reference (3) has submitted his online report (PART-II) along with his Site Inspection Report to Chief Conservator of Forests, Belagavi Circle, Belagavi.

In turn, the Chief Conservator of Forests, Belagavi Circle has submitted his report (Part-III) vide reference (4) and uploaded it online vide reference (5).

The proposal and the reports of field officers have been examined. The details of the forest land involved are given below:

The Deputy Conservator of Forests, Ghataprabha Division, Gokak has inspected the project site on 03-08-2016 and has reported the following:

- 1. Proposed area is bare minimum and unavoidable.
- 2. No trees are required to be felled.
- 3. Proposed forest area falls under as Eco-class-IV (Open forest).
- 4. There are no rare / endangered / unique species of flora and fauna in the proposed area.
- 5. There are no protected / archeological / heritage sites / defence / establishments located in the proposed area.
- 6. Proposed area does not form part of any Wildlife Sanctuary, National Park, Biosphere Reserve, Tiger Reserve or Elephant Corridor, etc.
- 7. The forest is not vulnerable to erosion.
- 8. There is no violation reported under Forest Conservation Act, 1980.

The Deputy Conservator of Forests, Ghatabrabha Division, Gokak has visited the area identified for Compensatory Afforestation by User Agency on 19-07-2016 and reported as follows.

The area of non-forest land selected for Compensatory Afforestation is at Sy. No. 700 of Khanagaon Village having 142-07 acre of Government Gayarana land in Gokak Taluk. Out of this area the User Agency has identified 16-28 acre i.e., 6.75 ha of non forest land for transfer to Karnataka Forest Department and further stated that the area is suitable for Afforestation work.

Further the said 16-28 acre (6.75 ha) of non-forest land in Sy. No. 700 of Khanagaon Village, Gokak Taluk has been mutated in favour of Karnataka Forest Department vide MR No.H36/2017-18 dated 20-09-2017. Copies of RTC and mutation extract are also enclosed for reference. The DCF, Gokak has also submitted Compensatory Afforestation Scheme with financial outlay of Rs.17.213 lakh @ Rs.2.55 lakh / ha for raising Compensatory Afforestation over 6.75 ha of

non-forest land. However, the same needs to be revised in accordance with present rate of Compensatory Afforestation (i.e., Rs. 2.72 lakh per ha).

The Chief Conservator of Forests, Belagavi Circle, Belagavi has also inspected the site on 22-10-2017, and has recommended the proposal for acceptance, duly agreeing with the recommendations of the Deputy Conservator of Forests, Ghataprabha Division, Gokak. Further, in his report dated 24-10-2017 he has opined that "there is vast forest area of about 100 ha downhill of the proposed canal. Since the area forms the part of the command area of the proposed canal, it is prone for encroachment by the private land holders adjoining the forest area downhill. Hence the User Agency may be instructed to erect a permanent fencing either by chain link mesh or stonewall along the boundary of the forest area downhill of the proposed canal to prevent encroachment in future." Accordingly, in this regard, a specific condition for erecting chain link mesh / stone wall all along the boundary of Reserved Forest downhill of the proposed canal at the cost of the User Agency may be imposed.

Further, the User Agency has to pay the Net Present Value (NPV) of forest land being diverted under this proposal as per conditions stipulated by Government of India, Ministry of Environment and Forests, New Delhi vide letter No. 11-9/98-FC dated 13-02-2014 and Orders dated 28-3-2008 and 9-5-2008 of the Hon'ble Supreme Court of India in I.A.No. 826 in I.A. 566 in WP(C) No. 202/1995. The User Agency has submitted an Undertaking to pay the charges towards Net Present Value (NPV).

With regard to compliance of Recognition of Forest Rights (RoFR) Act 2006, the User Agency has furnished requisite Certificate in Form-I issued by the Deputy Commissioner, Belagavi District vide No. RB/LND/SR-287/2014-15 dated 07-02-2015 as per guidelines issued by Ministry of Environment and Forest, New Delhi, vide F. No. 11-9/1198-FC(Pt) dated 03-08-2009/05-07-2013.

Under the above circumstances and agreeing with recommendation of the field officers, it is requested to kindly move this proposal with the Government of India, Government of India, Ministry of Environment, Forests and Climate Change, Regional Office (Southern Zone), Bengaluru for according 'in-principle' (Stage–I) for a period of thirty (30) years, subject to the specific condition that User Agency shall pay the cost towards erection of chain link mesh / stone wall all along the boundary of Reserved Forest downhill of the proposed canal for the length of the canal inside forest area as per the estimate prepared by the Deputy Conservator of Forests, Ghataprabha Division, Gokak and conditions appended in Annexure 'A'.
