Sub: Regarding compliance certificate towards settlement of Forest Rights in 0.497 Ha of forest land proposed for diversion under Medinipur Forest Division in Paschim Medinipur district for construction of Loop Out of 400kV D/C Chanditala - Kharagpur Transmission Line at 765/400 kV Medinipur Sub-station.

Sir,

With reference to the subject mentioned above, we would like to apprise you that POWERGRID Medinipur Jeerat Transmission Limited [A 100% wholly owned subsidiary of Power Grid Corporation of India Limited (POWERGRID)] has been entrusted with execution of Eastern Region Strengthening Scheme (ERSS-XVIII) which consists of the construction of Loop Out of 400kV D/C Chanditala - Kharagpur Transmission Line at 765/400 kV Medinipur Sub-station.

It is to mention here that some portion of aforesaid transmission line passes through Medinipur (0.497 Ha) Forest divisions under Paschim Medinipur district for which forest diversion proposal has been already submitted to state forest department as per provisions of the FC Act, 1980 and same is under process for necessary clearance.

However, the clearance of the forest proposal inter-alia requires a certificate from concerned Deputy Magistrate stating that "**all the rights of the Forest Dwelling Schedule Tribes (FDST) and other Traditional Forest Dwellers (OTFD) are settled in the forest area proposed for diversion before the final forest clearance of the proposal**" as per provisions of the forest right act, 2006.

Therefore, being the Chairman of the District Level Committee for FRA. We, hereby, request you to kindly ascertain if, there is any claim under FRA in the 0.497 Ha forest land for which forest diversion has been sought by POWERGRID Medinipur Jeerat Transmission Limited.
