Sub: Diversion of 40.79 ha of forest land in Khanapur, Kapilpur, Dhannur (Sevanagar) and 7 other villages in Bhalki, Bidar & Humnabad Talukas of Bidar District for widening of existing road in Bidar-Humnabad Section km 0.00 to 101.40 of NH-50 to two/four lane with paved shoulders in favour of Executive Engineer, National Highway Division, Kalaburagi. Proposal No.FP/KA/ROAD/33965/2018-reg.

With reference to above cited reference, it is to submit that the proposal for diversion of 40.79 Ha of forest land in Khanapur, Kapilapur, Dhannur (Sevanagar) and 7 other villages in Bhalki, Bidar and Humnabad Taluks of Bidar district for widening of existing road in Kamalnagar-Bidar-Humnabad section from km 0.00 to 101.40 of NH-50 to 2/4 lane with paved shoulders has been considered in the 44th meeting of Regional Empowered Committee (REC) on 29.05.2020. The REC has asked to submit a revised proposal with considered reduced width in forest area instead of 45m width.

The reduction in width of land for road purpose in forest reach has resulted in reduction in area of forest land from 40.79 Ha to 20.0724 Ha. The deputy commissioner in their order No.ಕಂ:ಎಲ್:ಎನ್:ಡಿ:ಸಿಆರ್-102/2019-20 dtd:26.11.19 has approved to transfer Govt. land measuring 81.58 Ha for Compensatory Afforestation in lieu of diversion of forest land of 40.79 Ha. Now, forest land requirement has reduced to 20.0724 Ha. Accordingly, Government land measuring $2 \times 20.0724 = 40.1448$ Ha Poramboke land in Kabirabad village of Hallikhed hobli, Humnabad Taluka will be transferred to Forest Department for CA land.

4. Longitude and Latitude readings of CA land

40.1448 Ha of poramboke land in Kabirabad village, Hallikhed (B) Hobli, Humnabad Taluka belonging to Revenue department has been identified for compensatory afforestation land in consultation with Revenue Department and Forest Department. The title of said land is also being processed simultaneously. It is requested to kindly process this Forest Clearance application pending transfer of title record for this.
