This has to reference no.1, cited above vide which Reginal Empowered Committee has asked to submit a revised proposal with considered reduced width in forest area instead of 45m width. The Committee has also asked to include box culverts for safe movement of wildlife. So also asked to furnish suitability certificate for the proposed CA land. Later PCCF (Head of Forest Force) letter No. E-office File No. KFD/HOFF/A5-4(GFL)/452018-FC-KFD dated: 15/16.06.2016 (E-6514) cited under reference had endorsed the copy to this office with a request to upload the compliance with all the relevant documents in PART-I of FORM-A in FC web-portal.

In this regard, earlier the undersigned had uploaded data in online 'Parivesh' Portal for diversion of 40.79Ha forest area in additional information of the PART-I of FORM-A online application, now we couldn't able to change the area in **item A-1 Project Details of section A General Details**, as the check box for editing the area was not available.

3. Hence, there is a change in the forest area to be diverted and details mentioned in online PART-I of FORM-A application and hard copy of the FC application submitted to your good office.
