

## **A TENTATIVE RECLAMATION SCHEME OF QUARRY LEASE AREA APPLIED BY M/S. SAI SONU GRANITES, CHITTOOR TOWN & DISTRICT.**

1. M/s. Sai Sonu Granites, Chittoor applied for quarry lease for Black granite of Basavapalli Exnt, RF, Chittoor District over an extent of 3.56 Ha for a period of 20 years.
2. Soil erosion measures such as gully plugging, check damming and other afforestation works shall be undertaken under the guidance of Forest Department. The entire mine area of 3.56 Ha reclaimed by filling outside soil into the voids created. Thus retaining the near original landscape.
3. During the lease period the dumps shall be consolidated by sowing hamata grass and constructing the contour bunds below the dump bottom and edge. Avenue plantation shall be undertaken along the road. The dumps will have inverse slope contour benches so that water is retained and no silt is washed off.
4. The estimated cost of reclamation is given as annexure. The cost of reclamation of 1 Ha out to Rs.93,000/- for preparation work, planting and maintenance of seedlings.
5. The total cost of reclamation plan of 3.56 Ha will be Rs.3.232 Lakhs which shall be undertaken by the lease.




