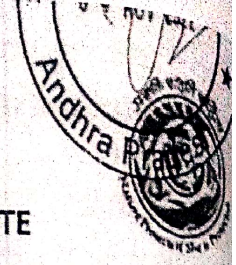

Sir,

Please refer to the subject and reference and to inform that the draft Working Plan of **Kakinada Division of Rajahmundry circle for the period from 2022-23 to 2031-32** received from the PCCF Andhra Pradesh has been examined with reference to the provisions of Forest (Conservation) Act, 1980, National Forest Policy, 1988 and National Working Plan Code and after careful consideration, I am herewith convey the Central Government's approval to the draft Working Plan of **Kakinada Division of Rajahmundry circle for the period from 2022-23 to 2031-32**, subject to the following conditions:-


1. No permanent structures shall be constructed in the name Eco-tourism and shall be abide with the provisions made under Forest (Conservation) Act, 1980;
2. Felling of trees in areas having slope more than 30 degrees and clearance of any growth up to 30M on either sides of banks of rivers/streams shall not be undertaken;

3. No felling shall be undertaken without prior approval of this office as per the Ministry order dated 23rd February, 2018 and this office letter No 07th February, 2019;
4. CA land received from User Agencies in lieu of diverted forest area needs to be notified as Reserved Forests / PF and details report shall be submitted in this regard within 3 months from the date of issuing of this order;
5. Without regenerating the clear felled area, no new felling shall be taken up in succeeding year;
6. Special emphasis shall be given for completion of proper demarcation of the forest areas with permanent boundary pillars;
7. Fire protection measures shall be taken up annually and adequate funds for this purpose shall be made available by State Government;
8. Planting of exotic species shall be kept bare minimum. Special emphasis shall be given for raising of native species during the plan period;
9. The Standing instructions /orders issued by the Hon'ble Supreme Court from time to time in W.P.(C)No.202/95 as well as under similar Writ Petitions shall meticulously be followed;
10. The detailed report indicating area harvested if any, and the area regenerated in a year shall be sent to Integrated Regional Office, Chennai, by 30th of April every year;
11. This approval does not ipso-facto imply approval of any proposed non-forestry activities requiring clearance under Forest (Conservation) Act, 1980. Such activities shall not be undertaken until separate forest clearance is obtained under the FCA, 1980;
12. No non forestry activity shall be taken up / allowed in the forest area in violation of the Forest Conservation Act, 1980;
13. The breaking up of soil shall not be done using a bull-dozer. However, suitable site specific soil preparation works may be carried out to prevent soil erosion;
14. Stock maps in 1:10000 scale of all plantations shall be prepared and resources survey of all the plantations shall be done for better management of plantation;
15. Division map in 1:250,000 scale, Range Management maps in 1: 50,000 scale, Beat maps in 1: 10,000 scale may be prepared. List of maps thus printed and their proposed distribution may be incorporated in the plan.
16. Construction of new roads in forest area shall not be taken up for the purpose of extraction of timber etc;

It may please be ensured that provisions of Forest (Conservation) Act, 1980 and guidelines issued thereunder are strictly followed while implementing Working Plan prescriptions. The Central Government reserves the right to review, modify or withdraw this approval, if any of the conditions of approval are not implemented or amendment to plan is necessitated.

The working plan will be due for revision in the year 2031-32 and steps may please be initiated for revision of working plan at **least two years prior to the expiry of validity.**


