Sub: Diversion of 40.79 ha of forest land in Khanapur, Kapilpur, Dhannur (Sevanagar) and 7 other villages in Bhalki, Bidar & Humnabad Talukas of Bidar District for widening of existing road in Bidar-Humnabad Section km 0.00 to 101.40 of NH-50 to two/four lane with paved shoulders in favour of Executive Engineer, National Highway Division, Kalaburagi-Compliance to 44th meeting of Regional Empowered Committee.

With reference to above cited reference, it is to submit that the proposal for diversion of 40.79 Ha of forest land in Khanapur, Kapilapur, Dhannur (Sevanagar) and 7 other villages in Bhalki, Bidar and Humnabad Taluks of Bidar district for widening of existing road in Kamalnagar-Bidar-Humnabad section from km 0.00 to 101.40 of NH-50 to 2/4 lane with paved shoulders has been considered in the 44th meeting of Regional Empowered Committee (REC) on 29.05.2020. The REC has asked to submit a revised proposal with considered reduced width in forest area instead of 45m width. The committee has also asked to include box culverts for safe movement of wildlife. So also asked to furnish suitability certificate for the proposed compensatory afforestation land and to furnish the status of Environmental clearance for the said project.

1) Reduction of Road width:

It is to submit that the undersigned has discussed the subject matter of reduction of Right of way width of road with Director General (Road Development) and Special Secretary, Ministry of Road Transport and Highways, New Delhi during the video conference on 3.06.2020 and it has been instructed to apply for not less than 30m width of ROW land for 2 lane with paved shoulder projects. Accordingly, the revised proposal has been prepared and uploaded for 30m width of road in all forest reaches and for 45m width for 6 lane road in the case of 350m stretch of Dhumansur forest. This 45m width of ROW land in Dhummansuru village is necessary to accommodate 4 lane elevated carriageway and service roads on either side to serve as Bypass road to Humnabad town. Thus, the total requirement for diversion of forest land gets reduced from 40.79

Ha to 20.0724Ha. Revised application of diversion of this 20.7687Ha of forest land is now been uploaded in forest portal.

2) Box Culvert for passage wildlife:

The revised proposal includes construction of Box culverts for safe movement of wildlife. It is to submit that the major wild animals present in and around the area of these forests include Blackbuck, wild Pig, Jackal, Common Langur, Peafowl.

The DCF Bidar in his ltr No. ఎ5/భు.ಪ/ఎనోజీహో–50/సిఆరో–04/2019–20/317 Dtd:14.07.2020 has requested for construction of following Box culverts:

1) Khanapur to Naubad : 2 Nos
2) Byalhalli : 2 Nos
3) Kabirabad : 1 No.
Total 5 Nos.

The DCF Bidar has requested for 2No. of Box culverts at Byalahalli village. But as per site condition, length of forest in Anadur village is more than Byalahalli forest stretch and hence one each Box Culvert at Byalahalli and Anadur have been proposed for construction to provide safe crossing of Wildlife.

The details of Box Culverts which have been proposed for safe movement of wildlife is as under.

Necessary drawings and estimates for above 5 Box culverts are here with uploaded along with this forest proposal.

3) Environmental Clearance:

This project does not require environmental clearance (EC) and the details of criteria for EC is submitted as under:

As per Environmental Impact Assessment (EIA) Notification 2006, roads and highways projects have been kept in Category "7f" and are appraised both at centre (Category A) as well as state level (Category B) depending upon the criteria specified under the notification and has to undergo EC procedure like any other project depending on the Category (A or B) of the project. As per the EIA notification, as applicable to roads and highways projects, cost criterion has been replaced with other threshold criteria related to length of National/State Highways (NHs/SHs) with additional right of way (ROW) requirement and applicability of General Conditions. Accordingly, New NHs and also expansion of NHs>30 km length involving additional ROW>20m involving land acquisition and passing through more than one state necessarily obtain EC from Central

Government (Category A) and new SHs along with expansion of NHs/SHs > 30km length involving land acquisition for additional ROW>20m (within one state) shall obtain EC from State Environment Impact Assessment Authority (SEIAA) (Category B1).

The total length of this project is 101.40 km. Private lands for 6.44Km stretch is being acquired for this project. Whereas diversion of forest and is sought for 14.70 Km length. Village-wise lands involving acquisition of land & diversion of forest land is produced below:

As explained in the above table, total stretch of private lands being acquired involving additional ROW>20M is 5.65 Km and total stretch of forest lands involving additional ROW>20M is 2.03Km. Thus, this entire NH-50 project requires acquisition of private land and diversion of forest land for 5.65+2.03=7.68Km length involving additional ROW>20m, which is within prescribed limit of 30km and hence Environmental Clearance procedure is not required for this project.

So also it is submitted that as per Office Memorandum No. J-11015/200/2008-IA.II(M) dated:31.03.2011 issued by Ministry of Environment & Forests, GOI, the project involving diversion of forest land, the User Agency has to first apply for stage-1 forest clearance for the forest land involved in the project and thereafter submit the proposal for obtaining Environmental Clearance as per the procedure prescribed under EIA Notification, 2006.

4) Returning of abandoned NH road land to Forest Department:

Sharp curves are being straightened by re-aligning the existing NH road alignment. Due to this re-alignment, following extent of road land becomes surplus is not being used for new road project.

The above 2.8550Ha extent of abandoned NH land is hereby surrendered to Forest Department.

Land for Compensatory Afforestation (CA):

The land for compensatory afforestation measuring 2 x 20.0724 = 40.1448 Ha has been identified in Poramboke land in Kabirabad village of Hallikhed hobli Humnabad Taluka.

The Deputy Commissioner Bidar in their order No.ಕం:ఎల్:ఎన్:డి:ఓఆర్-102/2019-20 dtd:26.11.19 has approved proposal to transfer 81.58 Ha land from Revenue department to forest department for the diversion of 40.79Ha forest land. Upon reduction in width of land from 45m to 30m, the total requirement of forest land diversion is also reduced from 40.79 Ha to 20.0724 Ha. Accordingly, following data has been uploaded in forest portal "Parivesh" in respect of 40.1448 Ha of CA land.

- 2) Village Map showing the location of CA land
- 3) KML polygon map
- 4) Longitude and Latitude readings of CA land.

 The title of this land will be transferred to Forest Dept.

Suitability certificate for the proposed compensatory afforestation land may kindly be obtained from DCF Bidar so as to comply the observations pointed out by Regional Empowered Committee.
