Subject: Letter of Intent for proposed Retail Outlet Dealership at Location- "MATKHEDA TO MILAK KHANAM, ON SUAR - BILASPUR ROAD (BW Km Stone Nos 8 and 15" Distt. Rampur State UP, Under Category Open.

Dear Sir,

We refer to your applications dated 20/07/2009 for Retail Outlet Dealership at Location. MATKHEDA TO MILAK KHANAM, ON SUAR - BILASPUR ROAD (BW Km Stone Nos 8 and 15, Distt. Rampur State UP Under Category Open. and subsequent interview held at Meerut on 10/11/2009. By this letter of Intent, we propose to offer you the Retail Outlet dealership of Hindustan Petroleum Corporation Limited at the above location on the terms and conditions mentioned below:-

- That you will lease the suitable plot of land (duly filled/excavated the land to the satisfaction of HPCL upto plinth level including the retaining wall) to HPCL for a period of 15 years with one renewal option for another 15 years. In case the offered land is taken on lease by you, the head lease should contain a clause that you should have a right to sublease the said plot of land to HPCL without further reference to the Head Lessor for the lease period as stipulated above, under such terms and conditions as may be agreed upon between you and HPCL. In case you fail to make available the offered land within two months, this offer is liable to be withdrawn. However, there is no commitment from HPCL for taking the said land from you.
- HPCL will develop the Retail Outlet on the said plot of land and provide the same to you with certain facilities like Sales Room bldg., Storage Tank, Pump, driveway, Toilet, Generator Room, Yard lighting etc., as early as possible.

Additional facilities (site specific) may also be developed by HPCL on its sole discretion as may be decided by HPCL from time to time.

- c. For the facilities that may be provided by the Corporation as aforesaid, we will recover from you licence fee as may be decided by Corporation and applicable to you from time to time. At present, the licence fee recoverable is Rs.47/- per KL for MS and Rs.40/-per KL for HSD.
- d. The Corporation will not be held liable for any loss or damage on account of delay that may be caused in providing you the facilities mentioned above, whatever may be the cause of such failure or delay.
- e. You will be notified by Corporation in writing after the facilities mentioned above are made available and they are ready for commissioning the Dealership and immediately on receipt of the above notice from Corporation, you shall, within a period of two months, comply with the following requirements and produce proof thereof to our satisfaction.
 - i. You have obtained each and every licence necessary for operating your Dealership as may be required under any Central/State Govt./Municipal or Local Authorities for the time being in force and
 - ii. You have resigned from your employment if you are employed and obtain the Letter of Acceptance from your employers. In case you are Member of Parliament/Member of Legislative Assembly, acceptance of your resignation shall be submitted from the Speaker of the House.

Please note that failure to comply with the two requirements mentioned in (i) & (ii) above will entitle the Corporation to withdraw this Letter of Intent without making any further reference to you, purely at your own risk.

- f. You shall not induct any partner(s); in case of individual nor make any changes in the constitution of the partnership as existing at the time of application.
- g. It will always be a basic condition for an award of MS/HSD Retail Outlet Dealership that you shall operate the Dealership personally and shall not assign or part with the same to any other person(s).
- h. That you will have to pay a refundable interest free security deposit of Rs Two lacs at the time of appointment.
- i. That you will make all efforts to retail fuel and non-fuel products promoted by HPCL from time & time and also facilitate the corporation in the effort to promote all products and activities from your retail outlet.
- j. The LOI holder on his appointment as dealer of the retail outlet at the said site shall ensure that minimum wages shall be paid to all the staff of the retail outlet. The dealer shall open savings bank account for all his key staff and shall ensure that the wages are credited in their respective bank accounts every month.

If we find that the progress being made by you towards the above is not to our satisfaction, this offer is liable to be withdrawn.

The dealerships to you will, on your complying with the conditions spelt out herein above, be formalized /confirmed by an appointment letter followed by the signing by both you and us on our standard dealership agreement.


