

Please note conveyor corridor is not passing through M/s. Mineral Enterprises Ltd but passing through M/s.Jantakal Enterprises. It is to be noted that jantakal mine is not operating and forest clearance has not been granted . We, therefore request forest department to facilitate the grant of our conveyor corridor through Jantakal lease as there is no other option to route the conveyor 3. We have reviewed the required width of conveyor corridor and have reduced it from initial 30 mtr to required 15 mtr. 4. All enclosed/uploaded documents are in english only
