

Detailed Project Report for improvement of sewerage network in Karnal Town including 27 Nos. newly approved colonies and 9 Nos. villages under NGT of Karnal Town, "Providing, Laying, Jointing, Cutting, S.W. pipe and RCC pipe NP3 of various sizes & all other works contingent thereto in recently approved colonies (Shalimar Colony, New Bahadur Chand Colony, Anand Vihar & Saini Colony) of Karnal Town.

The approval of Chief Engineer (U) to the NIT amounting to Rs. 206.35 Lacs (Rs. Two Crore Six Lacs and Thirty Five Thousand only) for the above cited work is hereby conveyed subject to the financial regularities and following conditions: -

CONDITIONS: -

- 1 All the cuttings and corrections be got attested by the Engineer-in-Charge before upload on website for e-tendering
- 2. The expenditure against the work shall not exceed over the administratively approved estimate and funds sanctioned for the work.
- 3. The concerned Superintending Engineer shall approve the Constructional and Structural design & drawings, X-Section, L-section and Sewer Design Statement before taking the work in hand.
- The time limit is 12 (Twelve) months.
- No change in specifications and scope of work shall be made without specific approval of this office.
- The quantities provided and calculated in the NIT shall be the responsibility of the Engineer-in-Charge.
- The physical scope of work taken in NIT should not be covered in any other administratively approved estimate under any programme
- The detailed estimate of the work shall be submitted within two months to this office for its technical sanction
- The sanction under rule 9.5.1 of PWD code be taken from the competent authority before taking the work in hand.
- 10. The Engineer-in-Charge will adopt the 3rd party inspection. The inspection and sample testing charges will be borne by the Department
- 11 The correctness of the Ground level and Bed level of the proposed /existing Sewer mentioned in the NIT is the responsibility of Engineer-in-Charge
- No work should be executed in unapproved colonies
- 13 The contractor is required to verify the water table, bearing capacity and other Geo Physical conditions before tendering and no subsequent payments of design, dewatering/lowering of subsoil water, pile foundation, price escalation, any royalties etc. will be made on this account

Further, it is requested to adopt the e-tendering process and the earnest money shall be through RTGS only for the said work and the approved NIT is enclosed herewith.
