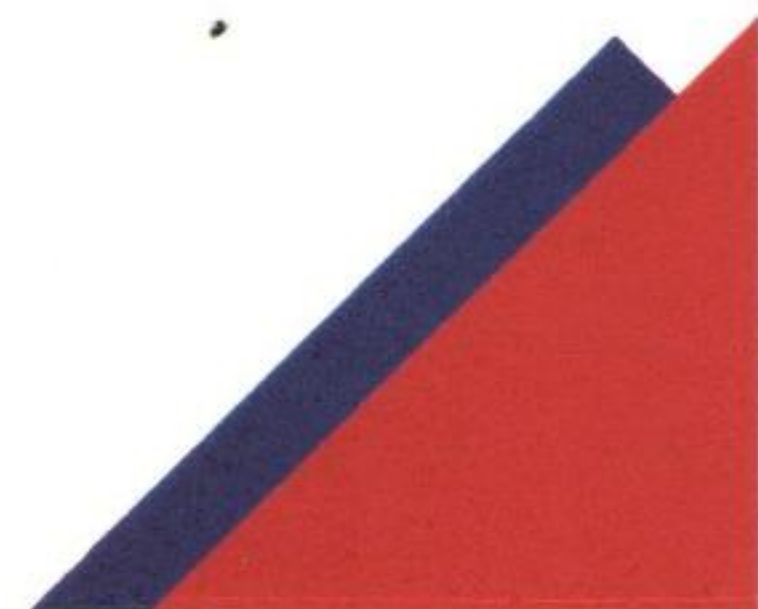

As per the report of Divisional Forest Officer (Wildlife) Hamirpur the comments of undersigned are as under:-

1. That the distance of above mentioned project site on Pharari Nala Tributary of Beas River is 8.74 Kms from the nearest boundary of Dhauladhar Wildlife Sanctuary and .74 Kms from nearest boundary of Eco-Sensitive Zone of Dhauladhar WLS.
2. That there will be no negative impact on the flora, fauna and ecology of the Dhauladhar WLS.

However, while taking further necessary action in the matter it may be ensured that all the instructions, rules, stipulations and guidelines on diversion of land are strictly observed and adhered to.
