This is to bring to your kind notice that in response to the 2<sup>nd</sup> cited reference, we write to your good self that, we M/s Total Environment Habitat Pvt Ltd, 4 /41 Thuner Main Road, Near GCP,Doddabetta, Udhagamandalam , The Nilgiris -643002 / the user agency have Purchased land in R.SNO 629, 630/2B, 2C, 2D, 2E, and 2A1 of Ootacamund Rural village , Ootacamaund , Taluk , Doddabetta Panchayatt, Ootacamund, The Nilgiris in which construction of environment friendly Resort is Proposed.

The user agency has been using the approach road to the proposed site, which is already been in existence and utilized by their predecessor in title(Tea Factory) , now by paying Annual licence fee ever since 2011 in the name of user agency and the same has been renewed annually. Since the User agency wish to develop the aforesaid land had submitted online application ( Parivesh) under section 2 of the Forest ( Conservation) Act 1980 to The Principal Chief Conservator of Forests( Head of forest Force ) , Chennai , for diversion of 0.225 Ha of fresh forest land for approach road to the aforesaid land in which construction of Resort is proposed, under FP/TN/Road /26490/2017 .

2) FMB SKETCH of the proposed land for conversion of road, in view of the records being called for in the 2<sup>nd</sup> cited Reference.


