With reference to the above subject, GAIL (India) Limited proposed to lay Natural Gas Pipeline along with its OFC from Mumbai to Nagpur, passing through 10 districts in Maharashtra. The Pipeline route is aligned within the RoW of Samruddhi Mahamarg.

In this regard, GAIL has submitted a re-diversion proposal online in Parivesh Portal vide proposal no. FP/MH/Pipeline/139865/2021, with total forest land area of 17.7978 Ha. There is a change in area after concluding the site visit of Thane & Washim Forest Divisions, the total forest land is changed to 18,0801 Ha. Divisionwise breakup for the same has been mentioned in the table below with old & new forest area.
