महोदय,

कृपया उल्लिखित विषय पर आपके पत्रांक CCL/Dir.(T)(O)/leasehold area/Piparwar/2013/301, dt. 21-26/02/13 संलग्न दिनांक 21.02.2013 के प्लान संख्या PO/PPR/mine plan/Boundary ADJ/2012-13/103 DT.13.0213, & PO/PPR/mine plan/Boundary ADJ/2012-13/103A DT.13.0213, and PO/PPR/mine plan/Boundary ADJ/2012-13/103B DT.13.0213 को संदर्भित करें।

The matter has since been examined on the basis of the information furnished and also shown on the plans as mentioned above duly signed by Director(T)(O)/Owner & Surveyor, Manager of both the mines and submitted by you along with this application.

In exercise of the powers conferred on the Chief Inspector of Mines (also designated as Director-General of Mines Safety) under Section 6(1) of the Mines Act, 1952, I hereby permit you to adjust the mine boundary between Piparwar and Ashoka project, and re-adjust the mine boundary within leasehold area of Piparwar OCP, so that after re-adjustment of the mine boundaries the final boundary of Piparwar OCP and Ashoka OCP will be P2, P17, P18, D, E, Y, X, W, G, O9, P10, P11, P12, P1 and P2 and A, B, C, D, E, Y, X, W, V, U, T, S, R, A respectively which is shown on the plan bearing no PO/PPR/mine plan/Boundary ADJ/2012-13/103 DT.13.0213, & PO/PPR/mine plan/Boundary ADJ/2012-13/103A DT.13.0213, and PO/PPR/mine plan/Boundary ADJ/2012-13/103B DT.13.0213, enclosed with the application subject to the following conditions being strictly complied with:

- 1.0 The changed mine boundary shall be demarcated on surface by suitable boundary pillars.
- 2.0 Co-ordinates of all important survey stations/change points shall be calculated correctly and shown on all statutory plans.
- 3.0 The changed boundary shall be shown on all statutory plans of the mine and all other adjacent mines having common boundary with Ashoka Opencast Mine.
- 4.0 A plan showing the new boundary shall be submitted within seven days of the said change as required under Regulation 3 of the Coal Mines Regulations, 1957.
- 5.0 Whenever the mine workings approach within 60m of the common boundary, provisions DG's Circular No.4 of 1971 shall be strictly complied with.
- 6.0 Please note that, this permission is subject to the following additional conditions.
- 7.0 Triangular part of the Nallah as shown in the plan along boundary in between point E&Y shall be straightened as far as possible and shall be strengthened by boulder pitching.
- 8.0 Strong embankment against proposed diverted Nallah shall be provided against Piparwar OCP as well as Ashoka OCP in consultation with and design provided by any scientific agency.
- 9.0 Necessary permission/exemption from this Directorate shall be obtained before starting any mining operations in new mine boundary as required under different provision of statute.
- 10.0 In the event of any change in the circumstances connected with this permission which is likely to endanger the mine or the persons employed therein, the mining operations for which this permission has been granted shall be stopped forthwith and intimation thereof shall be sent to this Directorate. The said operation shall not be resumed without an express and fresh permission in writing.
- 11.0 This permission is being issued specifically under the Regulation mentioned above and without prejudice to any other provisions of law, which may be or may become applicable at any time.



12.0 If at any time, any one of the conditions, subject to which this permission has been granted, is violated or not complied with, this permission, shall be deemed to have been revoked with immediate effect.

13.0 The above permission may be amended or withdrawn at any time, if considered necessary.
