State Government may upload VLC meeting proceedings of the said villages and submit the same in original also.	Village Level Committee (VLC) meeting proceedings of village Simayal, Bhandarisera, Saliya, Kafali and Jagura is uploaded at part-I and hard copy submitted vide this office letter no. 1595/2 2ई0व0भू0 dtd 27.06.2019 to your kind establishment.
2	In reply to point no.2 though the correct NPV calculation sheet has been uploaded but hard copy is not submitted. State Government may submit the original copy of revised NPV calculation.	Action taken from your end please.
3	In reply to point no.3 correct KML file of CA now uploaded and digital and SOI toposheet map of CA area is submitted but the revised maps have not been uploaded online. State Govt. may upload the revised maps of CA area online at designated place matching with the KML file.	Revised maps of CA area uploaded online.
4	The state Government has now uploaded the KML file and on perusal of KML file of road, it seems that target villages i.e.Nargoli and Bhandarisera are already connected with the road. Hence the requirement of the road is not justified. State Government may submit the justification for the requirement of the road.	Nargoli and Bhandarisera village are not connected from any other road. The proposed alignment start from Nargoli village, justification for requirement of road is enclosed in proposal at 1.5 (prapatra-11) as well as uploaded online.
