Sir,

As approved by the Superintending Engineer, 7th Circle, HPPWD Dalhousie letter No. SEVII-R-Hydro Project /2014-15- 4212-13 dated 26.06.2014, No Objection Certificate in respect of above mentioned project is hereby issued subject to the following conditions :-

The No Objection Certificate will be automatically cancelled if the company does not full fill the condition laid by the department.

That any protection work required for the protection of PWD property (Road Bridges and Buildings) including protection to hill slope shall be provided by the H.P. State Electricity Board Ltd. (A State Govt. undertaking) at his own cost as per the requirement and approval of such protection work from the public Works Department.

That wherever a channel is required to cross the PWD road a suitable R.C.C. Culvert /RCC bridge Steel Bridge as per the requirement of Public Works department shall be provided by the above said H.P. State Electricity Board Ltd. (A State Govt. undertaking) at its cost and after getting approval of the General arrangement and structural design of such bridge/culvert from the public works department.

That the width of the road land and vertical clearance above the highest point of road at the location of any type of road crossing shall be as per the requirements of Public Works Department subject to a minimum of 12.00 and 6.00 Meters respective of the existing width of road.

That any damage caused to the Government /Private property due to any activity of the project construction shall be made good to the entire satisfaction of the Engineer-in-Charge of the PWD at the entire cost of the above H.P. State Electricity Board-Ltd. (A State Govt. undertaking)

That any surplus material if any shall be dumped at pre-identified location/dumping sites.

The violation of all or any of the above terms shall result in cancellation of any permission/No objection Certificate granted by the Public works Department.

The H.P. State Electricity Board Ltd. (A State Govt. undertaking) shall be responsible for any type of damage/loss carried to life or Govt. property and all the expenditure involved for compensation /restoration shall be borne by the company.

The project shall be constructed beyond the controlled width of PWD Road as per HP Road Side Control Act.
