Sub: Proposal for NOC for access permission to the proposed fuel station of M/s Indian Oil Corporation Limited on NH-30 (Old NH-24) in km. 279 (Ch. 278.543, RHS) at Village-Bakargani, Tehsil-Faridpur & District-Bareilly in the State of Uttar Pradesh.

Sir,

Please refer to your letter dated 06.11.2020 (Ref.-1) and subsequent compliance dated 27.04.2021 (Ref.-3), vide which you have submitted the proposal for issuance of provisional NOC for access permission to the retail outlet mentioned in the aforesaid subject.

- The above proposal has been examined in this office in light of Ministry's guidelines issued vide letter No. RW-NH-33032/01/2017-S&R(R) dated 26.06.2020. Based on the Drawings, Checklist and associated documents and compliance of Ministry's norms and further recommended by you, the proposal has been approved 'In principle' by the Competent Authority, NHAI. The provisional NOC is being issued to the instant proposal, subject to the following conditions:
- The Provisional NOC is being issued on the basis of deposition of Processing Fee and Provisional approval fee in "Bharat Kosh" by the applicant. However, confirmation/ verification of the deposit receipts of "Bharat Kosh" is not submitted by PD. Hence, it is requested to confirm the deposit receipts of the same.
- Before issuance of NOC to the instant proposal, it is requested to obtain (ii) the following from the applicant:-
  - Bank Guarantee amounting to Rs. 2,50,000/- with a validity of three years from the applicant towards successful completion of access as per MoRT&H Guidelines dated 26.06.2020 and get confirmed all deposition in "Bharat Kosh".
- The Drinking Water and Toilet Facilities shall be provided at the retail outlet. Such facilities shall be accessible to the public round the clock. In order to inform the public about these, a retro reflective display board as per format enclosed at Annex-I shall be installed at the buffer strip in-front of retail outlet.

- (iv) For drainage, RCC slab culvert with minimum span of 2m shall be provided as per IRC: SP: 13-2004 - "Guidelines for the design of small bridges and culverts". The slab culvert shall be constructed with iron grating of adequate strength in the approaches for drainage of surface water. It must be ensured that outfall of above said culverts shall be led away to a natural course/outfall sewer through culvert or led away to a water-recharging system specifically constructed by the owner/management of the retail outlet/facility in case lined drains of sufficient length upto a natural course/outfall sewer are not available.
- (v) The applicant shall ensure the video recordings (before and after completion of construction work) of the site and that the work is done as per approved drawings, failing which action will be initiated to de-energize the retail outlet.
- (vi) To ensure safety and to avoid development of any future Black Spot, additional signs on cross roads within 300m of proposed retail outlet along with provision of rumble strips may be provided by the owner of fuel station in consultation with IE/PD. Further, responsibility of maintenance of these signs and marking shall also vest with the owner of retail outlet.
- (vii) The approval is based on the submissions made by the Applicant as verified by the PD-Bareilly. The Applicant is responsible for the details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
- (viii) Any unauthorized access from the National Highway shall be cut-off and necessary action be taken as per Ministry's guidelines.
- 3. The provisional NOC, however, shall be subject to the stipulations of the Ministry's Circular issued vide letter No. RO-NH-33032/01/2017-S&R(R) dated the 26<sup>th</sup> June, 2020.
- 4. The Oil Company may construct the access to the proposed retail outlet, as per approved drawings at their own cost within one (01) year of the issue of this Provisional NOC. After the construction as per approved drawings and the certification by the PD-Bareilly that the construction work has been carried out in compliance with the provisions approved, the issue of final formal permission including issuance of signed license deed may be considered. In case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority. The concerned Oil Company would be allowed to energize the retail outlet only after the final approval by the Competent Authority.
- 5. The fresh License deed (duly indicating new NH No. along with chainage), in two originals, as per the standard format given in Ministry's circular dated 26<sup>th</sup> June, 2020, drawn on new stamp paper and duly signed by Authorized Signatory may be furnished at the time of issuance of final permission along with additional/different License fee, if any deposition receipt of "Bharat Kosh".


