Sub- Application for seeking access permission for proposed Retail Outlet of M/S Reliance BP Mobility limited on NH-22 (NH-77) at ch. 14.904 (R.H.S), Plot No. 1220, 1228, Khata no. 486,182, Mauza- Raghunathpur Imadpur, Thana: Bhagwanpur, Dist-Vaishali in State of Bihar.- .**Provisional NOC Reg.**

Please refer to this office letter u/r(ii) granting in-principle approval and your letter u/r(i) informing that the fee has been deposited through Bharat Kosh transaction reference no. 0405220016489 dated 04.05.2023 for Rs. 20,000/-, transaction reference no. 0405220017346 dated 04.05.2023 for Rs. 2,75,625/- & for 13,782 with 30005230027760 dated 30.05.2023 and Bank Guarantee for Rs. 2,50,000/- having BG No. 560GT02220980011 dated 18.04.2022 and requesting to issue provisional NOC for the subject proposal.

- 2. In view of above, the provisional NOC is hereby granted subject to the following conditions:
- (i) The licensee shall, within one year from date of receipt of the permission, but without interfering in any way with the highway traffic, complete the construction of the approach road (including deceleration/acceleration lanes) and shall make provision for drainage, signs and marking at his own cost and to the full satisfaction of the PD, PIU- Chhapra according to the approved drawings and specification. On completion of construction in accordance with checklist and conforming to the approvals, a completion certificate would be issued by PD, PIU- Chhapra after satisfying himself that it has been completed as per the approved drawings and specifications. A copy of the necessary completion certificate issued to the Oil Company may also be furnished to this office. In case, the construction is not done in one year, the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration.
- (ii) The applicant should adhere to the undertakings given by them in compliance to Para 7 to 10 of Annexure-I to Appendix of Ministry's letter No. RW-NH-

Any discrepancy would lead to violation of the Ministry's guidelines and the approval extended shall stand cancelled.

- (iii) It may also be noted that as per para-11 (ii) & (iii) of Appendix-1 of Ministry's guidelines mentioned above that Retail Outlet is supposed to have free drinking water and toilet facilities as per the policy of Ministry of Petroleum and Natural Gas. It shall also be ensured that Retail Outlet is provided with such facilities and this would be accessible to public round the clock. To inform the public about this, a display board showing location of such facilities be installed before entry to the Retail Outlet. The Oil Company should ensure that this will be implemented prior to energizing the new Retail Outlet. This may be confirmed along with the completion report.
- (iv) PD, PIU-Chhapra should examine the safety conditions at site consequent to construction of approaches. Compliance to the approved drawings and other conditions are to be ensured by the PD, PIU-Chhapra.
- (v) The concerned Oil Company would be allowed to energize the fuel station only after the final approval by Highway Administration. Oil Company should ensure that petrol pump should not be energized before issuance of Completion certificate by PD, PIU- Chhapra and final NOC from this office.
- Proposal for final approval shall be submitted to this office only after completion of access road in all aspects.
- 3. Two sets of duly approved drawings are enclosed with the provisional NOC however Licence Deed shall be signed after grant of the final approval from this office.
