ORDER:

In reference 2nd read above, the Chief Commissioner of Land Administration has informed that the Collector, Y.S.R Kadapa has reported that in order to ensure execution of Galeru Nagari Sujala Sravanti, Phase-II, an extent of 4913.03 acres of Forest land is required and as such the same extent of land has to be transferred to the Forest Department towards Compensatory Afforestation. The Government land to an extent of Ac.1412.35 cts in Sy No.1914, 578 etc of Chinnayerasala (v) and Sancherla(v) of Porumamilla(M) and M.Kambaladinne (v) of Mylavaram(M) has been identified and the Forest Dept officials have also given consent to take over the said lands towards Compensatory Afforestation. The Chief Commissioner of Land Administration has therefore requested to accord necessary permission to the Collector, YSR Kadapa District to transfer Government land to an extent of Ac.1412.35 cts in Porumamilla and Mylavaram Mandals of YSR Kadapa District to Forest Department towards Compensatory Afforestation in lieu of forest land required for GNSS Project Phase-II.

2. In the circumstances reported by the District Collector, YSR Kadapa and the Chief Commissioner of Land Administration, Government after careful examination of the matter hereby accord permission to the District Collector, YSR Kadapa to transfer Government land to an extent of Ac.1412.35 cts in Porumamilla and Mylavaram Mandals of YSR Kadapa District to Forest Department towards Compensatory Afforestation in lieu of forest land required for GNSS Project Phase-II.

3. The Chief Commissioner of Land Administration and the District Collector, YSR Kadapa shall take necessary further action in the matter.
