Area proposed to carryout Compensatory Afforestation is 4.80 ha and CA Scheme is also submitted for the same, whereas, KML file uploaded in Parivesh portal and area mentioned in 2.40 ha KML file for exact area shall be uploaded and soft copy of KML file shall be submitted.	Necessary correction to be made at DCF office level.
3.	CA scheme submitted along with the proposal is not approved by DCF, concerned. Since CA suitability certificate is submitted by DCF, Solapur, CA Scheme approved by DCF, Solapur shall be submitted along with Index Map/SOI Toposheet on 1:50,000 scale and Differential GPS map duly authenticated by DCF, Solapur.	Necessary certification to be done at DCF office level.
4.	Maps viz Index Map/SOI Toposheet on 1:50,000 scale of proposed area, Differential GPS map of land proposed for diversion and Project layout map submitted along with the proposal is not authenticated by competent authority. The same has to be duly authenticated by the competent authority in the State Forest Department and Submitted to this office.	Copies of i. Toposheet ii. Village Map iii. KML File iv. Geo reference map with starting & ending coordination, are enclosed herewith.
