We humbly state that, we have filed an application for grant of Mining Lease for Quartz, on 18.02.2010 over an extent of 400 hectares in compartment No 475 of Mundlapadu beat, C.S. Puram Section, Kanigiri Range, Giddalur Forest Division, Prakasham District. The Asst. Director of Mines and Geology, Markapuram and his office survey team along with forest officials inspected and surveyed the area and recommended for 9.39 Hectares and forwarded its recommendations along with 7sets of applications to the

Director of Mines and Geology. The Director of Mines and Geology has forwarded our application to the PCCF on 04.06.2012 for Forest Clearance.

Further it is submitted that all the necessary clearances were obtained from the Divisional Forest Officer, Giddalur, The Chief Conservator of Forest, Guntur and ROFR Act clearance Certificate from the Collector of Prakasam District. Further the Principal Chief Conservator of Forests, Guntur vide letter No: EFS02-15029/9/2020-FCA SEC-PCCF/FCA-3, dated 26-05-2021 to The Director of Mines and Geology requested the validity of the proposals forwarded for processing of our application and also requested to furnish the Check list of information as mentioned in their earlier communication to the DMG dated 15.06.2015 and 07.12.2017, afresh along with ADMG report.

In response to above letter, The Director of Mines and Geology in its Memo No.47377/D9/2010 dated 17-06-2021 instructed the ADMG, Markapur to inspect the area and submit a detailed report with latest stage along with checklist immediately for taking further necessary action in the matter; the ADMG, Markapur in Lr.No.425/M/2010 dated 20-07-2021 to the DMG submitted detailed report with a check list. Meanwhile as per the directions in the Memo No:3861432/P/2020 dated 16-07-2021 from The Director of Mines and Geology, Ibrahimpatnam, a Draft Mining Plan over the recommended area was submitted to the Deputy Director of Mines and Geology, Ongole on 11-08-2021 for approval through the ADMG, Markapur.

We submit that as per the guide lines of Forest Department, we have prepared draft Mining Plan for the applied area, and submitted to the Asst. Director of Mines and Geology, Markapuram, who in turn forwarded to the Dy. Director of Mines and Geology, Ongole for approval.

In the meantime, the Director of Mines and Geology, Ibrahimpatnam has rejected our application on dt. 09-02-2022 as per Section 10(A) (1) of MMDR amendment Act, 2015 since the application was filed on 18-12-2010{As the applied Quartz mineral changed from Major mineral to minor mineral}

Since the clearances from the Department of Forests are at an advanced stage, to keep our Quarry Lease application alive we have applied a fresh application in Form P on 03-11-2021 for the same extent with authenticated forest Map, along with the payments towards application Fees and Security Deposit.

Through the reference 5<sup>th</sup> cited above, the Deputy Director of Mines and Geology, Ongole, has approved the Mining Plan (AMP) on the Quarry Lease applied area.

Through the reference 6<sup>th</sup> cited above, the Assistant Director of Mines and Geology, Markapuram, has reported to the Director of Mines and Geology, that **There are no other applications in the subject area and that the No Objection Certificates and clearances obtained for the previous application from the concerned authorities and the detailed check list (required by the PCCF vide Lr. No: EFS02-15029/8/2020-FCA SEC-PCCF/FCA-3, dated 26-05-2021) submitted earlier holds good for the present application.**

Based on the Assistant Director of Mines and Geology's report, 7<sup>th</sup> cited above, the Director of Mines and Geology in his Lr. No: 3028/D9/2022, dt. 24-06-2022 to PCCF, Guntur has requested to process and accord clearance for the diversion forest land for non-forest purpose for grant of Quarry Lease over an extent of 9.39 ha in compartment No 475 of Mundlapadu Beat, C.S Puram, Section, Kanigiri Range- Giddalur Forest Division - Prakasham District.

Further it is submitted that we have identified non-forest land in sy.no23/1 Eknapuram [v], D.G peta, C.S puram, Kanigiri, Prakasham District for the purpose of dumping the Quartz mineral at a distance of 2.5 km from the Mining area.

Therefore, we kindly request you to expedite our application as we have spent considerable time of over 10 years, invested considerable amount in procuring land for CA and incurred other expenditure. We acquiesce with due respect as per the guidelines, certain omissions raised and documents required by the various departments and we had never derelict in processing of our proposal.
