Vide letter ref to WRTS-II/Navsari GIS/TLC/ dtd. 16.06.2022 we have submitted the Valsad Social Forest proposal of 2.7136Ha. area vide Proposal Reference No. FP/GJ/TRANS/155387/2022 Date:18.05.2022 through Old Parivesh Portal 1.0 for construction of 765KV D/C New Navsari - Padghe Transmission Line.But during joint inspection with forest department, there was reduction in Valsad Social forest area Vide letter ref to WRTS-II/ New Navsari/TLC/249 dtd. 18.05.2023 we have been parallely submitted the Valsad Social Forest proposal of 2.1533Ha. area vide Proposal Reference No. FP/GJ/TRANS/429315/2023 Date:15.05.2023 through Parivesh Portal 2.0 by mistake for construction of 765KV D/C New Navsari - Padghe Transmission Line due to technical issue in old Parivesh Portal 1.0.

As our 765KV D/C New Navsari - Padghe Transmission Line consist total 4 division Valsad South, Valsad North, Navsari and Valsad Social we need to modify/update all the divisions in Old Parivesh Portal 1.0 Proposal Reference No. FP/GJ/TRANS/155387/2022 Date:18.05.2022. and not in Parivesh Portal 2.0 as one transmission line should have one forest proposal.

Now we have modified the Forest Proposal FP/GJ/TRANS/155387/2022 Date:18.05.2022 for Valsad Social Forest of 2.1533Ha. and also updated the new kml kindly requested to vou consider our 2,1533Ha,hence it is file for FP/GJ/TRANS/155387/2022 Date:18.05.2022 forest proposal for Valsad Social Forest(2.1533Ha.) dismiss our Valsad Social forest proposal and FP/GJ/TRANS/429315/2023 Date:15.05.2023 submitted in Parivesh Portal 2.0.
